Chairman Price also reported...on the construction of the parking lot on the old Benton Evening News location. Weather permitting, concrete will be poured this week for a sidewalk and then the parking area. Marion Concrete with a price of \$20,241.00 will be doing the work. This parking lot will add 25 parking spots.

Chairman Price also reported...on the Campbell Building. Closed sign needs to be posted on the south side of the courthouse and an entrance sign directing the public to the east side entrance of the Campbell Building needs to be posted. River City Construction will be finishing the handicap parking area this week. Items to finish their work include a sump pump and a canopy for the east entrance. The outside of the building will be finished at a later date - weather permitting.

Chairman Price also reported...at the last meeting with Navigate Building Solutions, it was reported that no design was needed on the abatement for the courthouse.

Sheriff David Bartoni joined the meeting at 5:20 pm.
