FRANKLIN COUNTY FINANCIAL REPORT (CASH BASIS)
August 2014

I. GENERAL COUNTY REVENUE

The end of August marks the completion of 75% of the fiscal year. Many of our major revenue items continue to lag behind. You will continue to notice significant discrepancies in where we are now versus where we were this time last year. I continue to suggest that the county board consider amending the budget to reflect lower revenue estimates. This will require the board to make adjustments in expenditures as well. In my opinion, this will be necessary to prevent deficit spending for 2014.

II. GENERAL COUNTY DISBURSEMENTS

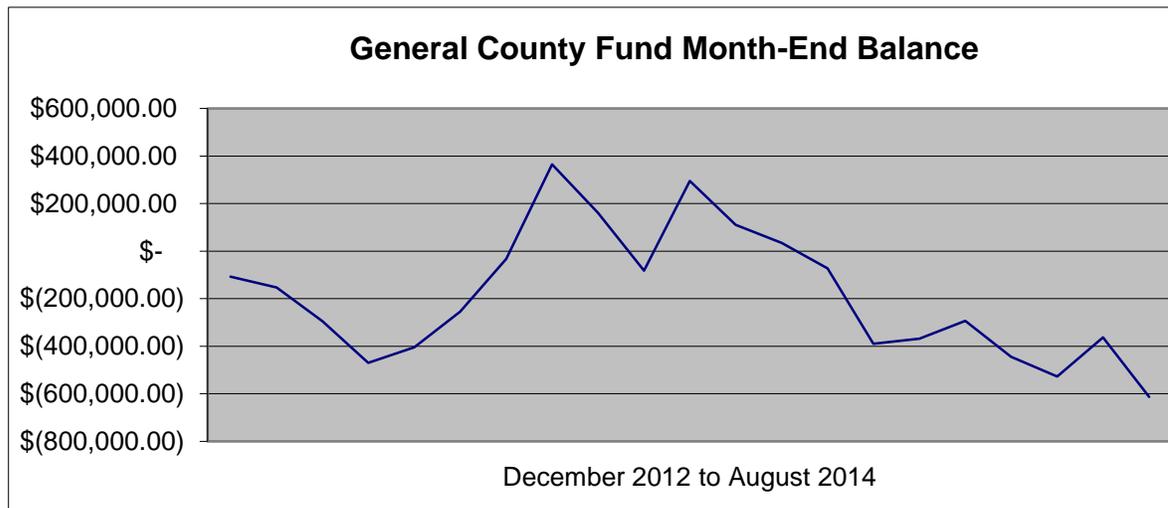
With a few exceptions, departmental spending continues to remain largely on-track. Transfers from contingency or other departments will be necessary to offset court-mandated spending in the Circuit Court budget and possibly the Sheriff's budget due to contractually-obligated back-pay. Again, the end of August represents the completion of 75% of the fiscal year.

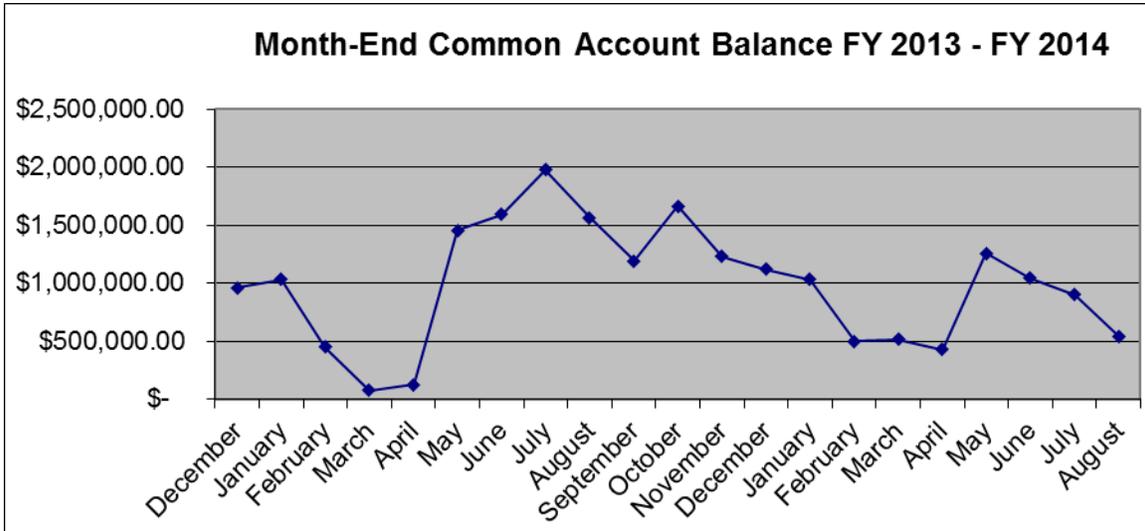
