Dear Mr. Leffler:

On behalf of Abbott EMS ("Abbott"), I am pleased to provide a list of services and rates for **Franklin County Coroner** ("Facility") regarding Body moves in the Franklin and surrounding counties in Illinois. This contract is for 1 full year of services and will automatically renew annually for additional 1 year terms until one or the other terminates agreement in writing with a minimum of (60) day notice.

As available and in most areas, ABBOTT can provide BLS body transports services to the Facility. In these cases, financial responsibility for ABBOTT's services rests with the facility. The Facility shall provide ABBOTT with any needed documentation at time of transport that will be used for tracking and billing purposes only. Facility responsible service rates are as follows:

ABBOTT will notify Facility following annual review, in writing, of any rate adjustment. The rate adjustment shall become effective the first day of the annual auto renewal date. ABBOTT will provide written invoices to the Facility for payment of the services. ABBOTT's invoices are NET thirty (30) days.

In the provision of services and the receipt of services, ABBOTT and the Facility shall comply in all material respects with all applicable federal and state laws and regulations, including, the federal Anti-kickback Statute. ABBOTT has made available to the Facility a copy of its Code of Conduct, Anti-kickback policies and other compliance policies, as may be changed from time-to-time, at AMR's web site, located at: www.amr.net, and the Facility acknowledges receipt of such documents. ABBOTT warrants that its personnel shall comply with ABBOTT's compliance policies, including training related to the Anti-kickback Statute. ABBOTT and Facility each represents and certifies that it is not ineligible to participate in Federal health care programs or in any other state or federal government payment program and shall not permit ineligible persons to order or provide services hereunder. It is not the intent of either party that any remuneration, benefit or privilege provided hereunder shall influence or in any way be based on the referral or recommended referral by either party of patients to the other party or its affiliated providers, if any, or the purchasing, leasing or ordering of any services other than the specific services described herein. Any payments specified herein are consistent with what the parties reasonably believe to be a fair market value for the services provided. Either ABBOTT or the Facility can end this relationship by providing the other written notice at anytime.


