

ANNUAL LEVY ORDINANCE

An ordinance levying taxes for all corporate purposes for the County of Franklin, Illinois, for the fiscal year commencing on the 1st day of December, A.D., 2013, and ending on the 30th day of November, A.D., 2014.

Be it ordained by the County Board, Franklin County, Illinois:

Section 1: that the amounts hereinafter set forth, or so much thereof as may be authorized by law, and the same is hereby levied for such purposes as: General, Corporate, Insurance, IMRF, Social Security, Bi-County Health, Human Services/Mental Health, Tuberculosis, County Highway, Federal Aid Matching, County Bridge Fund, and Senior Citizen services for the fiscal year of the said County of Franklin, Illinois, beginning the 1st Day of December, A.D., 2013 and ending the 30th day of November, A.D. 2014.
