

**RESOLUTION WAIVING THE COMPETITION REQUIREMENTS OF THE LOCAL GOVERNMENT PROFESSIONAL SERVICES SELECTION ACT FOR THE SPECIFIC PURPOSES OF THE DESIGN OF RENOVATIONS TO THE CAMPBELL BUILDING AND TEMPORARY COURT FACILITIES AND TO CONDUCT A PROFESSIONAL LAND SURVEY OF PROPERTY
(50 ILCS 510/8)**

WHEREAS, the Franklin County citizens have passed a resolution approve a one per cent (1%) increase in the county's share of local sales taxes for public facilities purposes, the construction of a new Franklin County Courthouse and to complete renovations to the Campbell Building to accommodate the offices of the Franklin County Clerk and Treasurer;

WHEREAS, that the Franklin County Board is in emergency need of an architectural firm to develop plans for the renovation of the Campbell Building and for the design of temporary accommodations for the court system while the old Franklin County Courthouse is being demolished and new courthouse is constructed as well as a land survey of county property to determine useable locations for construction.

WHEREAS, the current state of the old courthouse is such that further delay in design of the Campbell Building and temporary court facilities as well as in the conducting of a land survey would be detrimental to the citizens of Franklin County.

WHEREAS, the Franklin County Board estimates that or the cost of architectural and land surveying services for the projects discussed in this resolution are expected to be less than the statutory amount listed in 50 ILCS 510/8; (\$40,000 with increases annually by a percentage equal to the annual unadjusted percentage increase, if any, as determined by the consumer price index-u.)

WHEREAS, the Franklin County Board has established a satisfactory relationship with the architectural firm Kelly Architecture and Consulting of 11305 Fox Hunters Rd. Mulkeytown, IL 62865.

WHEREAS, the Franklin County Board has established a satisfactory relationship with the land survey firm Shawnee Professional Services LLC of 901 North DuQuoin Street Benton, IL 62812.


WHEREAS, the Franklin County Board desires to waive the requirements of Sections 4, 5, and 6 of 50 ILCS 510 et seq. and enter into an agreement with Kelly Architecture and Consulting to design renovations to the Campbell Building and design temporary accommodations for the court system while the old courthouse is being demolished and new courthouse is constructed.

WHEREAS, the Franklin County Board desires to waive the requirements of Sections 4, 5, and 6 of 50 ILCS 510 et seq. and enter into an agreement with Shawnee Professional Services to conduct a land survey of property for the construction of a new County Courthouse.

NOW, THEREFORE, BE IT RESOLVED, by the Franklin County Board as follows:

- A. That the Franklin County Board hereby waives the requirements of Sections 4, 5, and 6 of 50 ILCS 510 et seq. for the architectural design of renovations to the Campbell Building and temporary accommodations for the Franklin County Court system while the old courthouse is being demolished and new courthouse is being constructed **and** for a professional land survey of property for the construction of a new courthouse pursuant to 50 ILCS 510/8;
- B. That in the event that any clause or paragraph of this resolution are determined to be invalid, the remaining clauses and paragraphs shall survive.
