Good morning, Gayla:

Jason with Clearwave here. Hope all is well.

Per your request, please see attached our formal quote to provide Franklin County with our Hosted Phone and Analog POTS over Fiber telephone services.

Service details, pricing, etc. are all included in the attached quote. I'll do my best to provide additional high level context below. Please let me know what follow-up questions I can help answer for you:

- At its core, our Hosted Phone solution offers a brand new, fully managed, business class phone system with ongoing support over the life of the term installed at \$0.00 upfront cost owed to Clearwave
- The attached quote includes a cost comparison so you can easily see the net new monthly spend our Hosted Phone service represents compared to your already contracted Clearwave local/long distance telephone serviceat the Courthouse...as noted in the cost comparison, the net monthly uptick is \$605/month compared to what you're already contracted for...\$605/month extra over 60 months is \$36,300 total...we believe you'll have a difficult time finding a more competitive service quote that delivers a comparable set of hardware/features/functionality/overall value
- We will fully support, manage, train your employees, and maintain your Hosted Phone system for the
  duration of the term at no additional cost beyond what you see here (excluding standard telco taxes/fees or
  any outbound international calling you may use)...at the conclusion of the initial term we will negotiate a
  renewal term with you based on your specific needs at that time
- If a phone goes "belly up" due to natural causes over the course of the initial term we will dispatch and replace the phone at absolutely no additional charge to you...no dispatch fees, labor fees, etc.
- If you ever need to add additional phones or accessories just give me a call and our solution is easily scaled...adding equipment and/or features/functionality is the only time your monthly cost will increase during the term
- Unlike most VoIP providers, our Hosted Phone service is unique in that it <u>does not</u> go over the top of your fiber internet circuit...Hosted Phone uses a completely separate physical connection dedicated for voice traffic which helps ensure the overall quality of service for your internet and telephone services alike
- Unlimited outbound dialing within the Continental U.S. (CONUS) is included in our quote
- Any necessary inside network cabling/wiring is not included in the quote and will need to be completed by the customer prior to our Hosted Phone service going live

- As discussed, our Hosted Phone install schedule is already filled into January 2020 so we're going to have to
  expedite your project in order to try and meet your timeline...the sooner we can get a signed service order
  back from you the sooner we can begin planning the installation with the goal of having service ready at the
  Campbell Building when you need it
- When the time comes, we will relocate a TBD quantity of your phones from the Campbell Building into the new courthouse...it is the county's responsibility to provide dark fiber connectivity between the new courthouse and Clearwave's fiber demark inside the Campbell Building before we can successfully relocate the phones...the county will need to provide at least (2) dark fiber pairs dedicated for use with our phones at the courthouse...the fiber can be single mode or multi mode, but the county will need to let us know which type of fiber is being used so we can purchase the correct patch cables, SFP's, etc.
