The meeting was called to order at 5:04 PM by Chairman Alan Price. See above for list of those attending.

Price presented the claims for County Highway and asked if there were any questions on the claims. He also mentioned to the board that Navigate Building Solutions would be making a recommendation the following night on the selection of a contractor for the Courthouse.

County Engineer Mike Rolla then gave his report.

- Demolition has been completed on the old courthouse.
- The basement area was not supposed to be removed by the demolition team
- He also recognized Benton Fire Department for the large spray of water during the major part of the demolition which helped control the dust.
- County Highway had received a low bid of \$131,320 on the bridge on West City Road.
- Rolla has been able to replace 3 of the trucks that were lost in the recent fire.
- He has an estimate from Samron (which is under the requirement for bidding process) to asphalt the Campbell Building parking lot.
- He also mentioned a couple of other projects that will be coming up for his department. Discussion followed.

Randall Crocker mentioned the pole in the middle of the parking lot and would like to try to get that down/moved before the asphalt and that the a/c units still need to be fenced.

Price reported that the Benton High School time capsule was found and was returned to their Administrative Office.
