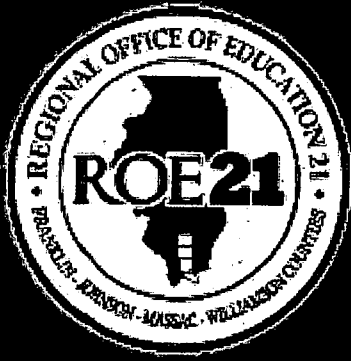
The Franklin County Board will begin accepting applications for the position of SUPERVISOR OF ASSESSMENTS.

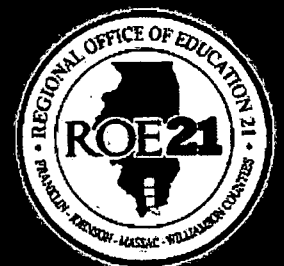

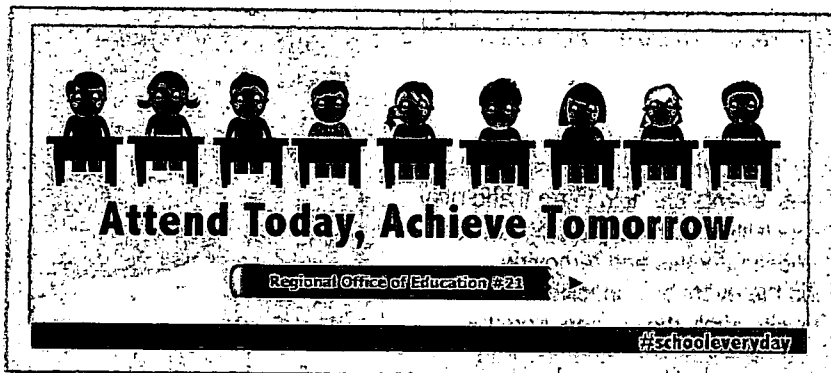
Educators who hold National Board for Professional Teaching certification at the time of license renewal must only complete 60 hours of professional development; holding National Board certification will fulfill 60 hours of professional development if you are a teacher/school support personnel. If you are an administrator, it will reduce the amount owed to 60 hours.

- School support personnel who hold the Illinois Department of Financial and Professional Regulation (IDFPR) license or national certification can use the license to waive all 120 hours of PD. Enter your license on your PD page in ELIS.
- Holding IDFPR or national licensure fulfills ALL 120 hours of professional development for school support personnel. This requirement has not changed.
- A School Support Personnel is a School Social Worker, School Counselor, School Psychologist, School Nurse, Speech-Language Pathologist (Non-Teaching).
- Paraprofessionals are not School Support Personnel and do not owe any professional development for renewal.
- Paraprofessionals and substitute teachers do not owe PD hours but must pay registration fees to renew the license.

**Holiday Messaging**

All families want what is best for their children, but they don't always realize how absences can add up to academic problems. Sometimes they allow children to miss school when it's not absolutely necessary. This often happens before and after the fall and winter holidays, as families try to squeeze a few more days out of the vacation season. At the same time, results of a parent survey suggest that families would be willing to shorten vacations if they believe the absences are affecting academic success. Principals and teachers have an opportunity to reduce holiday absences by ensuring that parents and students understand the toll that absenteeism takes on achievement. Attendance Works has developed some tools and messaging for school leaders hoping to encourage good attendance around the winter holidays. For more information or click [HERE](#).



**How can schools increase their attendance rate?**

According to the National Center for Student Engagement, schools are most effective in achieving high attendance rates when parents, school leaders and community members work together to focus on reducing absences and truancy, and keeping kids in schools. The center's Web site provides 10 tips for schools and communities to improve their attendance rates. Among them:

- Make the school a place where parents and students feel welcome.
- Forge a relationship with local law enforcement and make them allies in showing the community, family and students that school is the place to be.
- Forge a relationship with local businesses so that they cooperate in encouraging students to go to school and not congregate at businesses during school hours.
- Call parents – not an answering machine – when their children are not in school to let them know the school is concerned.
- Talk to students about why they were gone and let them know they were missed.

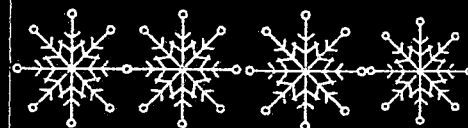

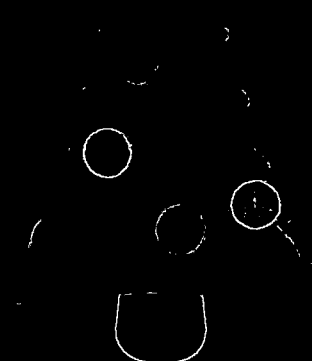

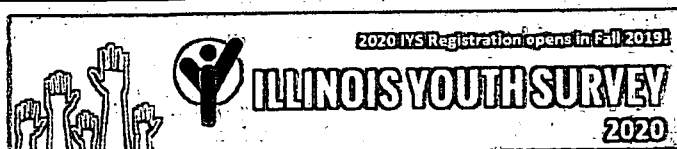

It's the Season to Register for the Illinois Youth Survey!

Please check with your administration to ensure your school is registered for the Illinois Youth Survey. The IYS has been used to survey the health and social indicators of Illinois youth since 1993, and creates individualized, easy-to-use reports that you can use to assess school needs, track progress towards your school's physical, social and mental health goals, and evaluate student support services.

The current survey period will be open January-May 2020 for all Illinois 8th, 10th, & 12th graders. Schools who are interested in surveying other grades are welcome to, but should understand that they will not receive comparative data.

**PRO TIP:** January and February usually have the least scheduling conflicts. Accurate data is at the heart of this survey, so it is important to schedule the survey during a time when all/most students are available. If a particular group of students are out for a field trip, then the data will not show the full picture of your school and may skew the data significantly.

## ILLINOIS DEPARTMENT OF NATURAL RESOURCE GRANT OPPORTUNITIES

### Illinois Biodiversity Field Trip Grant

Teachers of grades prekindergarten through 12 in Illinois, including home-schooling teachers, may apply to the IDNR through the ENTICE (Environment and Nature Training Institute for Conservation Education) program to receive funding for natural resources-related field trips. Bus transportation and substitute teacher fees are the primary expenses covered. Applications must be postmarked no later than January 31, 2020. The optional preliminary application deadline is January 15, 2020. Click [HERE](#) for the application form, instructional video podcasts and complete grant instructions. This program is made possible through the generous donations of the D. F. and M. T. Grohne Family Foundation in Wilmington, the Daniel F. and Ada L. Rice Foundation in Skokie and the Independence Tube Corporation in Bedford Park. Funding is administered by the Illinois Conservation Foundation.

### Earth Day in the Parks

Earth Day in the Parks is a natural-resources stewardship program for students. Available at participating IDNR state parks, museums and historic sites, events are held in April and May. Students are at the site for about two hours and conduct activities such as planting native wildflowers and grasses, building and installing nesting/roosting boxes and removing nonnative, invasive plants. Teachers must apply to attend the event at a specific site. A drawing is held for each site from the applications for that site. Only the winners from the drawing are allowed to bring their students to the event. Applications are accepted from January 1, 2020, through February 28, 2020. The drawing will be held in early March. ### Illinois' Pollinators Resources Trunks

The new Illinois' Pollinators resources trunks for loan from the IDNR Division of Education contain teaching tools to help you and your students explore the variety of pollinators in our state. Targeted to grades prekindergarten through six, there are resources included for classroom use as well as a backpack with field guides and equipment for pollinator observation in the field. Sections in the trunk include "What are Pollinators?," "Why are Pollinators Important?," "How Does Pollination Work?," "Helping Pollinators" and "Pollinator Gardens." Lessons are correlated to Next Generation Science Standards and Illinois Early Learning and Development Standards. There are currently 30 lending locations available. 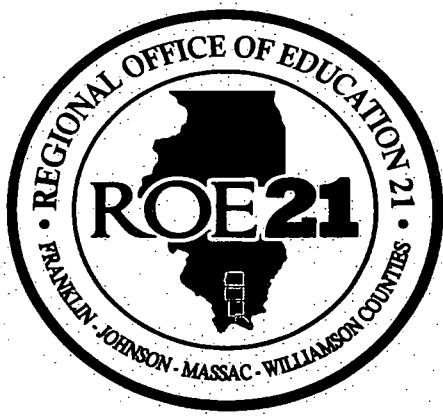

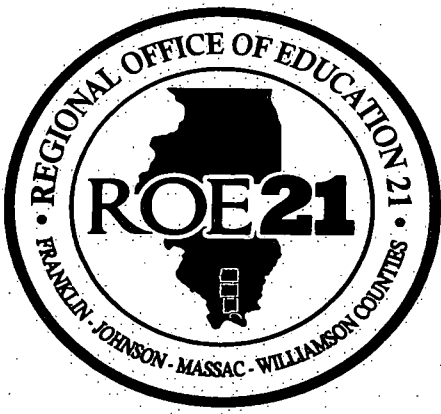
By state law, the members of the Regional Board will appoint a person to fill the vacant seat for Massac County. The appointee is required to live in Massac County since all other counties are represented on the board.

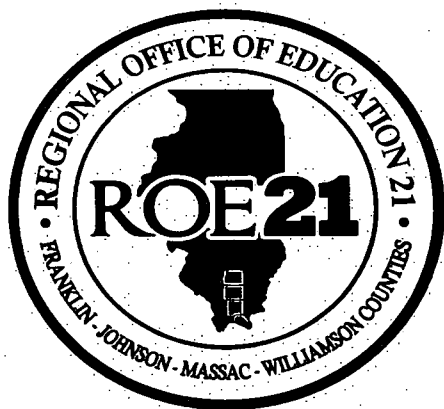

We know that historical and structural inequities have placed some of our children in situations of greater stress, trauma, and violence. Thus, trauma-informed practice that heals kids exemplifies equitable practice. I want to highlight Resilient Southern Illinois, one partnership that is supporting this healing by addressing students' unique needs. The innovative collaboration includes the Poshard Foundation for Abused Children, Illinois Education Association and Partnership for Resilience, and more than 15 school districts in Southern Illinois. Educators and staff in participating schools are provided with ongoing training and resources as they build relationships to support students experiencing trauma and nurture students' social-emotional development.

Resilient Southern Illinois speaks to the necessity of being in deeper relationships to care for the whole child, whole school, and whole community. Children are not preordained to be defined by their trauma. Mitigating buffers and protective factors can help children heal and overcome any ACEs score. People read over trauma-informed practice and do not understand how fundamentally important it is. Trauma-informed classrooms are places where all children are getting their needs met. We firmly believe that trauma-informed practice benefits every single child *and adult* in the classroom and in the school.

Our alternative and safe schools are partnering with Resilient Southern Illinois, where our staff participates in training and the implementation of trauma informed practices. We are transforming our schools with the knowledge and best practices to meet the social emotional and educational needs to best support our students.

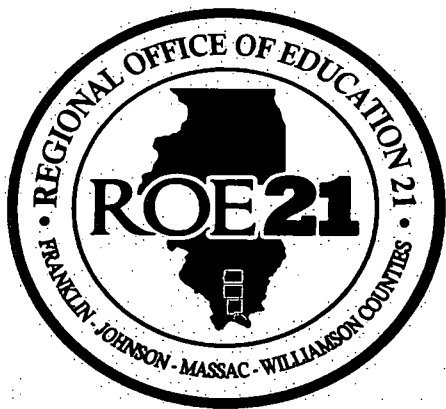

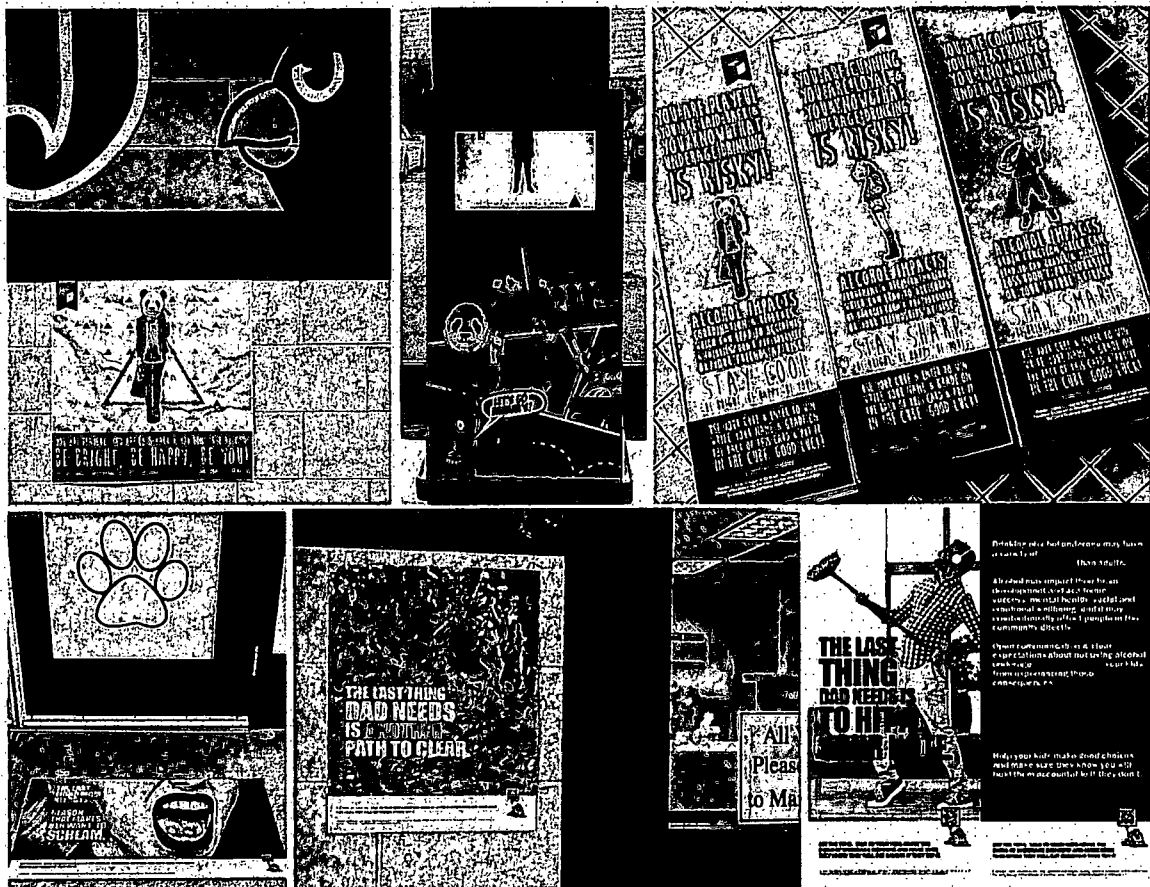

### Franklin County Regional Delivery System for Career and Technical Education (FCRDS- CTE) Education for Employment #525



FJMW Regional Office of Education serves as Fiscal Agent for the Franklin County CTE cooperative. The programs are funded by Federal Perkins Grant and CTEI Grant. Cooperating school districts include Benton Consolidated H.S., Christopher H.S., Frankfort Community H.S., Sesser-Valier H.S., Thompsonville H.S., and Zeigler-Royalton H.S.

Mr. George Hopkins serves as the Director of the FCRDS, whose IL State Board of Education identification is Education for Employment # 525. (EFE 525)

FCRDS-CTE operates two “Regional” CTE classes...available\* to Franklin County students:

--Don Wilburn is in his second years as the CTE Instructor for FCRDS Building Trades Regional Class serving students in the 2018-19 school year from Christopher, Sesser, and Benton. Projects of note: Construction of walls and soffits for a non-profit; on-site walls and ceilings for Ewing Government Offices; 12x20 storage facility.

--Lee Messersmith is the teacher/facilitator of Entrepreneurial Development, Growth and Education (EDGE) Class (the study of entrepreneurship). This class is now meeting in the MINCON Buildings, formerly Bombardier, in Benton Industrial Park.

The Franklin County Regional Delivery System supports programs in Agricultural Education, Business, Marketing, and Computer Education, Family and Consumer Sciences, Technology and Engineering, Health Science Technology.

Programs are supported through state and federal grants designed to supplement CTE programs. Allowable expenditures for these grants include: Instructional materials, instructional equipment (capital outlay); partial salary payments to districts to help ensure affordability of qualified instruction; tutorial services; and improvement of instruction activities.

The Franklin County Regional Delivery System for CTE funds also provide supplemental funds for (K-8) Career

Exploration programs at Akin CCSD 91, Benton CCSD 47, Christopher CUSD 99, Ewing-Northern CCSD 115, Frankfort CUSD 168, Sesser-Valier CUSD 196, Thompsonville CUSD 174, and Zeigler-Royalton CUSD 188.

FCRDS also conducts Workshops and hosts ISBE-sponsored professional development for educators in Franklin and Jefferson Counties per the CTE/Perkins Programs of Study requirements. FCRDS for CTE prepares and submits to Illinois State Board of Education various reports regarding program operation, assessment, and improvement.

As mentioned above, in addition to its funding support of all CTE classes in Franklin County high schools, FCRDS operates/supports two Regional CTE classes that are available to all students in Franklin County: Construction Trades Class and Entrepreneur Class (Entrepreneurial Development, Growth, and Education (EDGE)). Brief summaries follow:

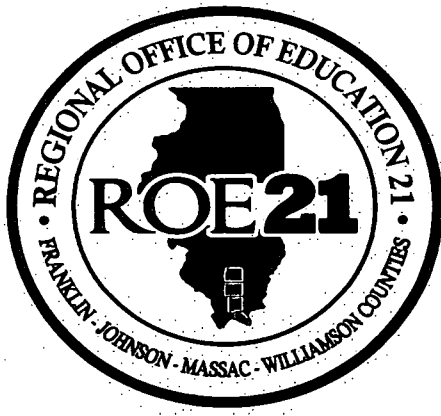
### Construction Trades Class

Over the past three years the students have built and sold a Tiny House and built items for the Benton Library Garden, including a 12'x16' storage facility. During the school year of 2018-19, students, under direction of instructor Don Wilburn, have constructed walls and soffits for non profit agency, walls and ceilings for offices at new Ewing Village Office, and a 12'x 20' storage facility, among other items. Now in its fourth year of existence, this year's Construction Trades class was the most successful and productive.

### Entrepreneurial (EDGE) Class

This entrepreneurial class acquaints students with knowledge and skills necessary to own and operate their own businesses. Topics of the class include economics, marketing principles and strategies, human relations and psychology, business and labor law, legal rights and responsibilities of business ownership, financial planning and accounting, and business communication. Students are required to plan and execute a business plan and operate a bona-fide business.

Per IL St Bd of Education rules, Intergovernmental Coop Agreement regulations, and Board of Control authorization, the CTE Director publishes notice of Joint Agreement Budget on review 30 days in advance of a public hearing that is conducted in August of each fiscal year at Regional Office of Education 21.

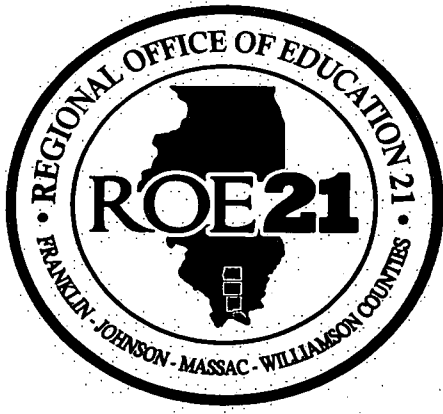
### ALLOCATIONS FOR FISCAL YEAR 2020

It is a Franklin County public shuttle operates/services Continental Tire in Mt. Vernon and Rend lake College. SStops in Marion, West Frankfort, Benton, Ina, and Mt. Vernon averages over 100 rides a day.

Franklin county also has the Redbird and Rangers routes that run between Benton and West Frankfort. SCT provides transportation for BCMW in Franklin County.

SCT employs 9 full-time employees and one part time.

Sara asked me to send you some info on Transfer Center in Marion. The Bus Depot is located in front of the V.A. Hospital on Main St. in Marion. The Depot has 7 bus slips with benches and electronic signs at each slip. There is a large parking lot on site also. The facility has a waiting area with restrooms and a large electronic sign for route schedules to be displayed. The facility is currently open for clients from 5:00 a.m. to 8:00 p.m. The facility and lot is equipped with a PA system for drivers to announce arrivals and departures. SCT has a dedicated slip on site that is identified by an electronic sign. Beginning November 4<sup>th</sup> the Olive Route, which is ran out of Franklin County, will be using the Depot for its Marion stop. The Olive Shuttle (Continental Tire Shuttle) will be at the Depot 6 times a day, 7 days a week. I have attached Olive schedule. The Jefferson Shuttle out of Mt. Vernon will also be using the Depot at some point in the near future. This shuttle makes stops in Benton and West Frankfort on its way back and forth from Mt. Vernon to Marion. The Bus Depot will provide a much larger service area for the riders in Southern Illinois. This Depot will serve as an access point for SCT, Rides, and Shawnee Transit Districts.
