MINUTES OF MEETING Dec 7, 2020

CALL TO ORDER

ELECT A VICE-CHAIRMAN

Ray Minor nominated Brad Wilson. John Gossett seconded the motion. No other nominations were made therefore the nominations were closed. On roll call vote, all board members voted for Brad Wilson.
