# Proposal for Part-time pay increase

- 1. Two part-time prisoner transport/ civil process at 24 hours each per week. (48 hours)
- 2. Two part-time correctional officers at 24 hours each per week. (48 hours)
- 3. One part-time court security officer at 24 hours. Two more will be needed for new courthouse. (72 hours)
- 4. This will reduce the correctional staff by two and eliminate a full-time civil process server.

  (Approximately \$150,000.00 salary savings plus overtime savings)
- 5. Current part-time pay is minimum wage. This greatly reduces the quality of interested persons.
- 6. Proposed part-time pay is graduated to current starting salary for position w/o benefits.
- 7. Immediate increase to \$12.50/hr. December 1<sup>st,</sup> 2019 increase to \$15.00/hr. December 1<sup>st,</sup> 2020 increase to starting pay for position.
- 8. Immediate increase will be \$1,500.00/ wk/\$6,000.00/mo.
- 9. December 1<sup>st</sup> increase will be \$1800.00/wk. At a cost of \$93,600.00/yr.
- 10. Current budget for part-time is \$17,000.00. Current balance is \$7,862,13
