Neil Hargis announced that Rick Litton would be at the next meeting to make a video presentation.

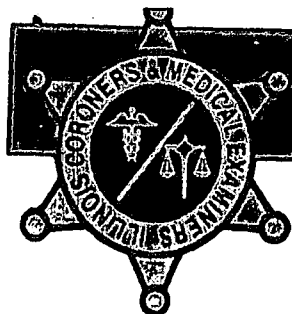
Randall Crocker explained items and appointments on the agenda for the regular March meeting.
