County Engineer Mike Rolla then gave his report...

- The Campbell Building east side parking area was finished. The bill from E.T. Simonds was \$22,534.10.
- He has called Sesser Pave & Seal for a price for the five parking spots and also "no parking" areas for the designated sheriff's area.
- Bridge work is to begin Monday, October 26, 2020 on West Center Road.
- County Highway will have 2 trucks, with the county board's approval, to list as disposal items. He will notify the townships to bid on these trucks if interested. Rolla will get bids and, again, bring those to the board for their approval.
- County Highway has started the dirt work and preparation on South Thompsonville Road.
- Macedonia Road was put on hold for a little while due to a problem with getting steel. That should resume soon.
