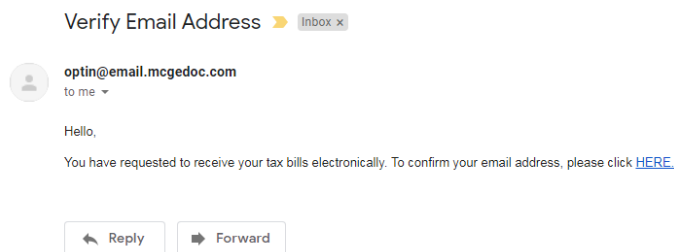
1. I understand that if I register for electronic billing, I will not receive a paper tax bill via U.S. Mail.
2. I certify that I am the owner of the parcel(s) for which I am registering for electronic billing, or I am authorized to act on behalf of the property owner.
3. I understand that failure to receive a tax bill, for any reason, does not alter my responsibility to pay taxes in a timely manner (35 ILCS 200/20-15). It is my responsibility to make sure that I receive the correct tax bill(s) and immediately notify the Franklin County Treasurer of any issues.
4. I understand that if I have difficulty accessing my electronic tax bill(s) for any reason, it is my responsibility to contact the Franklin County Treasurer to receive the bill(s) through other methods.
5. I understand that if a deed or land contract is recorded which changes the ownership of the parcel(s) or the tax bill mailing address, the electronic billing registration will be cancelled and the parcel(s) will revert to traditional paper billing via U.S. Mail.
6. I understand that a valid email address is required for electronic billing and that it is my responsibility to check incoming email messages regularly. If I cancel or otherwise discontinue use of the email address above, it is my responsibility to update or cancel my electronic billing registration.
7. I understand that if I choose to pay property taxes by mail, in person or at a local bank, I need to print the bill(s) and present the payment stub(s) with my payment. A duplicate bill fee of \$1.00 per parcel will be charged for any payment received without the payment stub(s).

If you do not click the link, your preference will not be noted; you will still receive a tax bill via mail to ensure you still receive a bill of taxes due.
- 8) Click the submit button on the website to finalize your preference to receive tax bills via email
