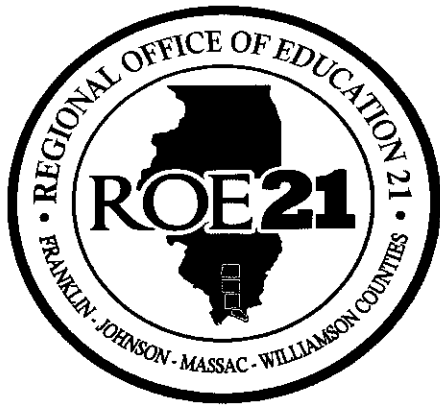

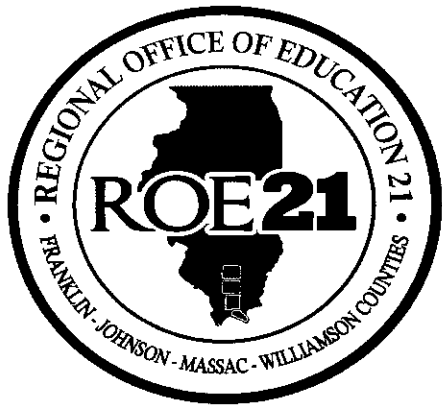

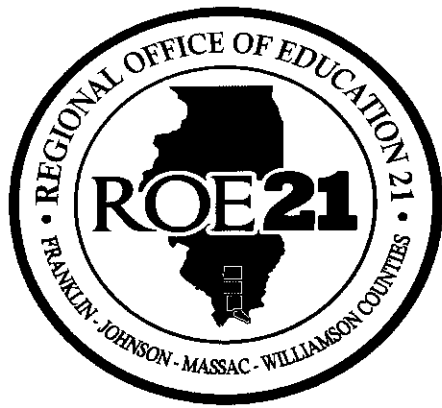

ROE #21 held 4 Administrator Academies.

ROE #21 has been able to provide differentiated trainings within many different content areas throughout the 2017-2018 school year. This has been made possible through the State-Wide System of Support Grant and Foundational Services. There have been **74 different training** sessions offered throughout this school year for teachers, administrators, and school staff members throughout ROE

#21. There has been a total of **988 individuals who have attended** some type of training this school year. Listed below are the topic areas, the number of trainings held, and the total number of participants for each topic area.



- English Language Arts- 12 sessions held with 128 total participants.
- Informal Needs Assessments- 3 sessions held with 9 total participants.
- Instructional Strategies- 24 sessions held with 476 total participants.
- Integrating Technology- 5 sessions held with 78 total participants.
- Mathematics- 13 sessions held with 84 total participants.
- Poverty- 2 sessions held with 35 total participants.
- Science- 7 sessions held with 49 total participants.
- Social Emotional Learning 2 sessions held with 30 total participants.
- Teacher Evaluation 1 session held with 11 total participants.
- Trauma- 5 sessions held with 88 total participants.

ROE #21 has also partnered with several entities to offer additional Professional Development Opportunities for administrators, teachers and school staff members. Some of the entities

SSOS Grant (State-Wide System of Support)

***The Franklin-Williamson Regional Office of Education #21 was awarded the SSOS Fiscal Agent Grant for FY14 for Area VI of the IARSS. This grant period began 7/1/2013. There are now 20 different initiatives targeted throughout this grant. Throughout the past few years, there have been seven initiatives targeted throughout this grant. Those initiatives include:*

- District/ Continuous Improvement Planning English Language Arts (ELA); Math; Teacher Evaluation; Balanced Assessment; Family Engagement and Science.
- This year there have been additional initiatives added to that list such as: Classroom Management, English Language Learners, Fine Arts, Instructional Strategies, Integrating Technology, Poverty, Physical Education, Trauma, Social Emotional Learning, Restorative Justice, Standards Based Grading, and Social Studies, Area VI has expert presenters in each content area. These experts have been providing differentiated sessions to all school districts throughout Johnson-Franklin-Massac-Williamson Counties.

Community Prevention Resources (CPR)



- This grant was funded beginning 8/1/17.
- This is a direct service sub-grant of Franklin-Williamson ROE 21.
- Funded for 2 FTE: Dave Lustenberger, Director; Kate West, Director; Project Manager.
- Dave Lustenberger, former Director, resigned July 1, 2018 for another great opportunity in his career and has been replaced with Kate West.
- Purpose of grant:
 - > Increase the availability of high-quality prevention services that have the greatest potential to impact factors that contribute to ATOD consumption and consequences of 11-18-year-olds.
- ROE 21 has been funded to provide PRESCRIBED evidence-based services in **Franklin and Saline Counties**. These services are limited to:
 - > Communication Campaign targeting youth (Planning Phase) at Central Jr. High School in West Frankfort, Harrisburg Middle School in Harrisburg, and Eldorado Middle School in Eldorado.
 - > Communication Campaign targeting communities (Planning Phase) in Franklin County and Saline County.
 - > Delivery of Youth Prevention Education Curriculum to 7th and 8th grade students at Central Jr. High School, Harrisburg Middle School, and Eldorado Middle School.
 - > Major Emphasis is placed on efforts to curb underage drinking and opioid/prescription drug abuse as data indicates these to be the greatest substance abuse issues facing youth.
- Based on recommendations from SAMHSA, the Department will focus on the Strategic Prevention Framework and Coalitions. It is their hope that these coalitions will be able to sustain efforts at a community level.
- Major emphasis is placed on efforts to curb underage drinking, as data indicates this to be the greatest substance abuse problem with youth.
- Works in partnership with the Center for Prevention Research and Development (U of I Chicago) to promote the participation of Illinois schools in the Illinois Youth Survey (IYS).
- Works in partnership with the Illinois Liquor Control Commission (ILCC) to ensure Illinois' compliance with the federal SYNAR regulations. These regulations require all states to reduce the sale of tobacco products to minors by enacting and enforcing minimum-age tobacco laws. CPR staff accompanies ILCC staff on vendor compliance checks in southern Illinois upon request.

Franklin County Regional Delivery System for Career and Technical Education (CTE)

FJMW Regional Office of Education serves as Fiscal Agent for the Franklin County CTE cooperative. The programs are funded by Federal Perkins Grant and CTEI Grant. Cooperating school districts include Benton Consolidated H.S., Christopher H.S., Frankfort Community H.S., Sesser-Valier H.S., Thompsonville H.S., and Zeigler-Royalton H.S.

Mr. George Hopkins serves as the Director of the grant and Kim Byars serves as the Administrative Assistant for CTE.



Will Carmickle is the CTE Instructor for FCRDS Building Trades Regional Class serving students from Christopher, Sesser, Thompsonville, and Benton.

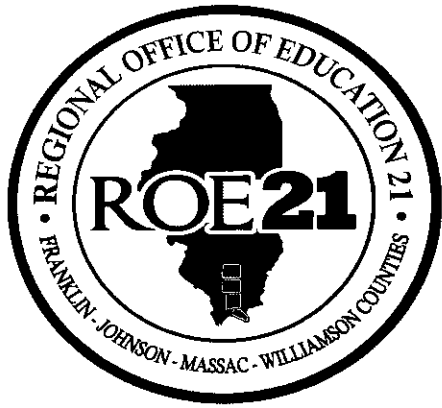
Kevin Weston serves as the Instructor for the Computer Assisted Drafting Regional Class (potentially students from West Frankfort and Zeigler).

The Franklin County Regional Delivery System supports programs in Agricultural Education, Business, Marketing, and Computer Education, Family and Consumer Sciences, Technology and Engineering, Health Science Technology.

Programs are supported through state and federal grants designed to supplement CTE programs. Allowable expenditures for these grants include: instructional materials, instructional equipment (capital outlay); partial salary payments to districts to help ensure affordability of qualified instruction; tutorial services; and improvement of instruction activities.

The Franklin County Regional Delivery System for CTE funds provide supplemental funds for (K-8) Career Exploration programs at Akin CCSD 91, Benton CCSD 47, Christopher CUSD 99, Ewing-Northern CCSD 115, Frankfort CUSD 168, Sesser-Valier CUSD 196, Thompsonville CUSD 174, and Zeigler-Royalton CUSD 188.

FCRDS also conducts Workshops and hosts ISBE-sponsored professional development for educators in Franklin and Jefferson Counties per the CTE/Perkins Programs of Study requirements. A Workshop for Career Awareness was held at the Benton High School Library July 26, 2018.

Grants Managed and Status for FY 2018

\$248,288 CTEI Grant Allotment shows a decrease from last year's original and amended application amount, but we may see additional monies become available as they did last year. This grant has been approved by ISBE. As of February 28, 2018, \$80,000 has been received from this state grant.

\$89,021 in Federal Perkins Grant This federal allotment represents a \$1,615 decrease in last year's amount. This grant has been approved by ISBE. To date, 12,030 has been received from this federal grant.

All Franklin County high schools have received their allotment figures for funds to be spent on CTE programming for FY 18.

Per Intergovernmental Coop Agreement regulations and Board of Control authorization, CTE Director Hopkins published notice of Joint Agreement Budget on review 30 days in advance of hearing. Hearing was conducted at 10 a.m. on 8/28/17, at Regional Office of Education 21.

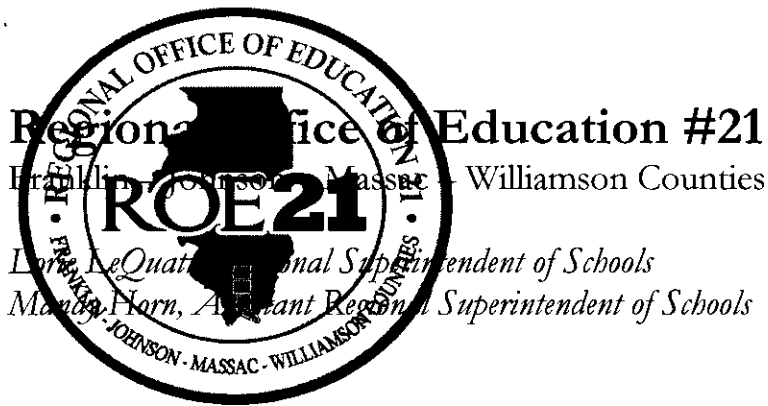
Professional Development

ROE #21 held 4 Administrator Academies.

ROE #21 has been able to provide differentiated trainings within many different content areas throughout the 2017-2018 school year. This has been made possible through the State-Wide System of Support Grant and Foundational Services. There have been **74 different training** sessions offered throughout this school year for teachers, administrators, and school staff members throughout ROE #21. There has been a total of **988 individuals who have attended** some type of training this school year. Listed below are the topic areas, the number of trainings held, and the total number of participants for each topic area.

- English Language Arts- 12 sessions held with 128 total participants.
- Informal Needs Assessments- 3 sessions held with 9 total participants.
- Instructional Strategies- 24 sessions held with 476 total participants.
- Integrating Technology- 5 sessions held with 78 total participants.
- Mathematics- 13 sessions held with 84 total participants.
- Poverty- 2 sessions held with 35 total participants.
- Science- 7 sessions held with 49 total participants.
- Social Emotional Learning 2 sessions held with 30 total participants.
- Teacher Evaluation 1 session held with 11 total participants.
- Trauma- 5 sessions held with 88 total participants.

ROE #21 has also partnered with several entities to offer additional Professional Development Opportunities for administrators, teachers and school staff members. Some of the entities include: Illinois Law Enforcement trainers, SIU Medicine, Northern Illinois University, County Farm Bureaus, U of I Cooperative Extension Centers, and drug prevention programs.

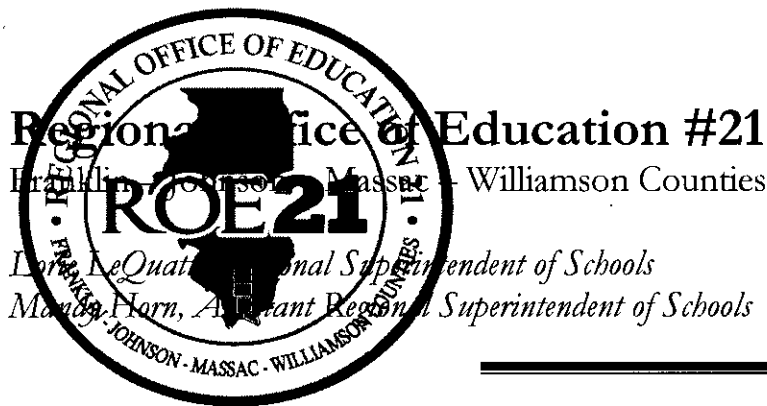


SSOS Grant (State-Wide System of Support)

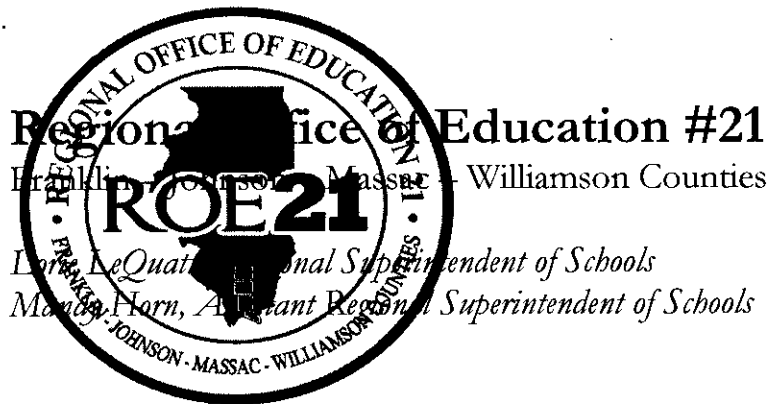
- District/ Continuous Improvement Planning English Language Arts (ELA); Math; Teacher Evaluation; Balanced Assessment; Family Engagement and Science.
- This year there have been additional initiatives added to that list such as: Classroom Management, English Language Learners, Fine Arts, Instructional Strategies, Integrating Technology, Poverty, Physical Education, Trauma, Social Emotional Learning, Restorative Justice, Standards Based Grading, and Social Studies, Area VI has expert presenters in each content area. These experts have been providing differentiated sessions to all school districts throughout Johnson-Franklin-Massac-Williamson Counties.

Community Prevention Resources

- This grant was funded beginning 8/1/17.
- This is a direct service sub-grant of Franklin-Williamson ROE 21.
- Funded for 2 FTE: Dave Lustenberger, Director; Kate West, Director; Project Manager.
- Dave Lustenberger, former Director, resigned July 1, 2018 for another great opportunity in his career and has been replaced with Kate West.
- Purpose of grant:
 - > Increase the availability of high-quality prevention services that have the greatest potential to impact factors that contribute to ATOD consumption and consequences of 11-18-year-olds.
- ROE 21 has been funded to provide PRESCRIBED evidence-based services in **Franklin and Saline Counties**. These services are limited to:
 - > Communication Campaign targeting youth (Planning Phase) at Central Jr. High School in West Frankfort, Harrisburg Middle School in Harrisburg, and Eldorado Middle School in Eldorado.
 - > Communication Campaign targeting communities (Planning Phase) in Franklin County and Saline County.
 - > Delivery of Youth Prevention Education Curriculum to 7th and 8th grade students at Central Jr. High School, Harrisburg Middle School, and Eldorado Middle School.
 - > Major Emphasis is place on efforts to curb underage drinking and opioid/prescription drug abuse as data indicates these to be the greatest substance abuse issues facing youth.
- Based on recommendations from SAMHSA, the Department will focus on the Strategic Prevention Framework and Coalitions. It is their hope that these coalitions will be able to sustain efforts at a community level.
- Major emphasis is placed on efforts to curb underage drinking, as data indicates this to be the greatest substance abuse problem with youth.
- Works in partnership with the Center for Prevention Research and Development (U of I Chicago) to promote the participation of Illinois schools in the Illinois Youth Survey (IYS).
- Works in partnership with the Illinois Liquor Control Commission (ILCC) to ensure Illinois' compliance with the federal SYNAR regulations. These regulations require all states to reduce the sale of tobacco products to minors by enacting and enforcing minimum-age tobacco laws. CPR staff accompanies ILCC staff on vendor compliance checks in southern Illinois upon request.



Franklin County Regional Delivery System

FJMW Regional Office of Education serves as Fiscal Agent for the Franklin County CTE cooperative. The programs are funded by Federal Perkins Grant and CTEI Grant. Cooperating school districts include Benton Consolidated H.S., Christopher H.S., Frankfort Community H.S., Sesser-Valier H.S., Thompsonville H.S., and Zeigler-Royalton H.S.

The Franklin Co Regional Delivery System, Education for Employment 525, provided in excess of \$202,000 in supplies and materials and \$42,000 in equipment (costing more than \$500) to the six high school Career and Technical Education (CTE) programs in fiscal year 2018. It is estimated that of the roughly 1,900 high school students in Franklin Co., approximately 70% take at least one CTE course, so the funds have positively affected as many as 1,330 students.

Mr. George Hopkins serves as the Director of the grant and Kim Byars serves as the Administrative Assistant for CTE. Will Carmickle is the CTE Instructor for FCRDS Building Trades Regional Class serving students from Christopher, Sesser, Thompsonville, and Benton. Kevin Weston serves as the Instructor for the Computer Assisted Drafting Regional Class (potentially students from West Frankfort and Zeigler).

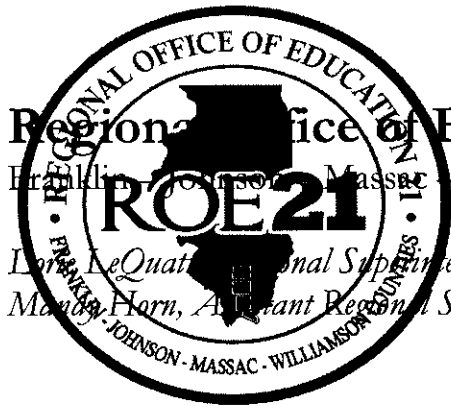
The Franklin County Regional Delivery System supports programs in Agricultural Education, Business, Marketing, and Computer Education, Family and Consumer Sciences, Technology and Engineering, Health Science Technology.

Programs are supported through state and federal grants designed to supplement CTE programs. Allowable expenditures for these grants include: instructional materials, instructional equipment (capital outlay); partial salary payments to districts to help ensure affordability of qualified instruction; tutorial services; and improvement of instruction activities.

The Franklin County Regional Delivery System for CTE funds provide supplemental funds for (K-8) Career Exploration programs at Akin CCSD 91, Benton CCSD 47, Christopher CUSD 99, Ewing-Northern CCSD 115, Frankfort CUSD 168, Sesser-Valier CUSD 196, Thompsonville CUSD 174, and Zeigler-Royalton CUSD 188.

FCRDS also conducts Workshops and hosts ISBE-sponsored professional development for educators in Franklin and Jefferson Counties per the CTE/Perkins Programs of Study requirements. A Workshop for Career Awareness was held at the Benton High School Library July 26, 2018.

FCRDS for CTE prepares and submits to Illinois State Board of Education various reports regarding program operation, assessment, and improvement.

Over the past few years the students have built and sold a Tiny House and built items for the Benton Library Garden. A new project is adopted each year.

Two “Regional” vocational classes, which are classes provided by FCRDS and are open to students in any of the six county high schools, have been operated for the last two years. Those classes are Construction Trades class, housed in Benton, and Computer Drafting, housed in West Frankfort. A third Regional class—an entrepreneurship class referred to as EDGE (Entrepreneurial Development, Growth and Education) will begin in 2018-19 school year. This class, administered by FCRDS, is being mostly funded by efforts of the Franklin Co Economic Development Corp—FREDCO. Presently, fourteen students are enrolled in this new class which will meet in various locations around the county but will use the Franklin Co Farm Bureau conference room as its home base.

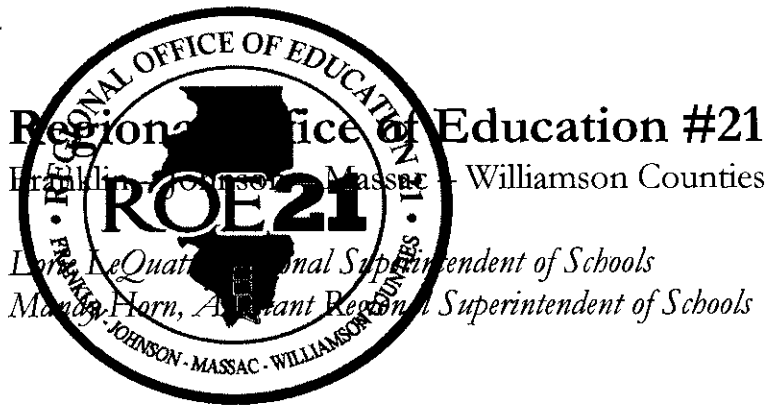

Grants Managed and Status for FY 2018

\$248,288 CTEI Grant Allotment shows a decrease from last year’s original and amended application amount, but we may see additional monies become available as they did last year. This grant has been approved by ISBE. **This grant was extended from June 30 to August 31 completion date. As of July 27, 2018, \$240,000 has been received from this state grant.**

\$89,021 in Federal Perkins Grant This federal allotment represents a \$1,615 decrease in last year’s amount. This grant has been approved by ISBE. **The grant ended on June 30, and all of these funds have been received from this federal grant.**

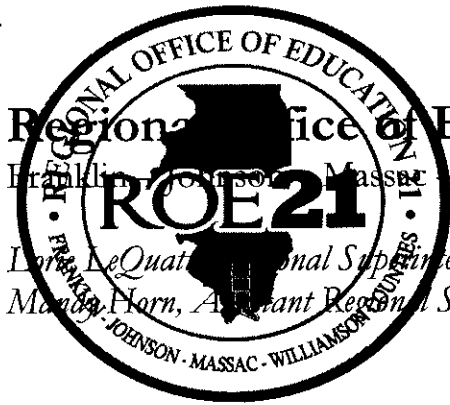


All Franklin County high schools have received their allotment figures for funds to be spent on CTE programming for FY 18.

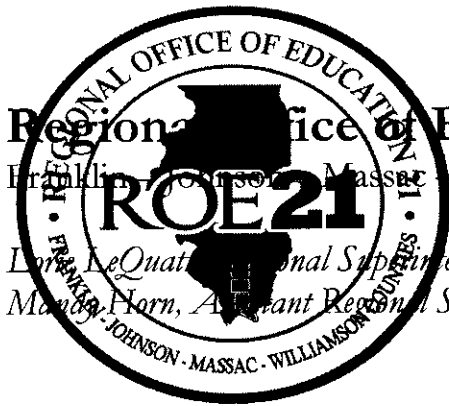

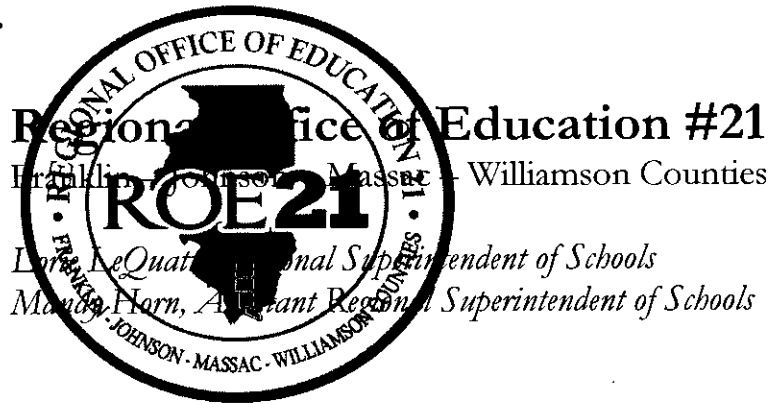

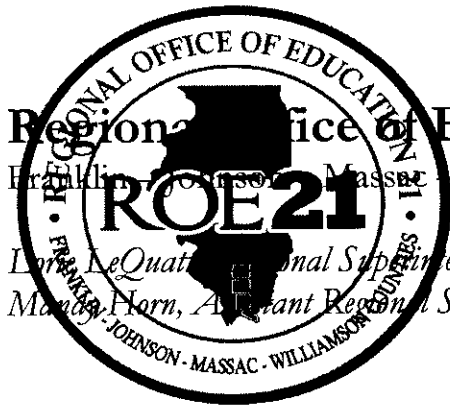
