Franklin County Sheriff, Don Jones reported the Franklin County Jail population was now at 121 and is grossly over populated, discussion was held concerning a solution to the problem and also the housing of mentally ill prisoners.

Franklin County Circuit Clerk, Jim Muir reported the new monitors were now installed in the courthouse and would be functional very soon. Mr Muir stated his office is working with the Franklin County States Attorney concerning the abandon bond monies and should have a answer soon.

Franklin County Treasurer, Pam Smith reported on the County finances and stated the state use tax had been received from the state and the flood monies due from the state was \$41,697.00. Ms Smith stated monies for Probation and the Detention Center was over 1 million and still owed by the state, discussion followed.

Franklin County Board Administrative Assistant, Gayla Sink reported the court security fees would increase to \$61.00 as of May 2017.
