CALL TO ORDER

NON UNION EMPLOYEE SALARIES

Chairman Randall Crocker informed the County Board that the next item on the agenda is the Non Union Employee Salaries for 2017 - 2019 and he asked Alan Price to explain. Alan Price stated the increase is 1 1/2%, 1 1/2%, and 3% raise. Cindy Humm's salary will be \$64,453 and Cathy Dial will be \$29,469 with a stipend for \$600.

Tom Vaughn made a motion to approve the Non Union Employee Salaries for 2017 - 2019 as presented. David Rea seconded the motion. On roll call vote, all voted yes.

PROPOSED THREE YEAR ENGAGEMENT LETTER FOR FRANKLIN COUNTY ANNUAL AUDIT

ENGINEERING AGREEMENT DEERING ROAD

Chairman Randall Crocker stated that the next item on the agenda is the Deering Road engineering agreement and he asked Mike Rolla, County Engineer to explain. Mike Rolla, County Engineer explained that there is a 36 inch pipe that needs to be looked into and he suggest hiring Chastain & Associates LLC Consulting Engineers from Benton and asked for approval.

Danny Melvin made a motion to approve the consulting engineers as presented. Stephen Leek seconded the motion. On roll call vote, all voted yes.

CROSSWALK COMMUNITY ACTION AGENCY - 2 APPOINTMENTS

Stephen Leek made a motion to reappoint Cindy Page and Jim McPhail to the Crosswalk Community Action Agency for a two year term ending December 31, 2019. David Rea seconded the motion. On roll call vote, all voted yes.

FRANKLIN COUNTY MENTAL HEALTH 708 BOARD - 2 APPOINTMENTS

Stephen Leek made a motion to reappoint Joyce Foglemen and Jim McPhail to the Franklin County Mental Health 708 Board for a four year term ending December 31, 2021. Danny Melvin seconded the motion. On roll call vote, all voted yes.

GREATER EGYPT REGIONAL PLANNING COMMISSION - 2 APPOINTMENTS

Chairman Randall Crocker stated that the next item on the agenda is two appointments for the Greater Egypt Regional Planning Commission, Jason Ashmore and Neil Hargis's terms will end December 31, 2017.
