ORDINANCE NO. 2021-05

**AN ORDINANCE AMENDING FRANKLIN COUNTY ORDINANCE NO. 2018-09  
TO AMEND TERRITORY OF THE FRANKLIN COUNTY I-57  
ENTERPRISE ZONE**

**WHEREAS**, on November 20, 2018 the County Board for the County of Franklin, Illinois (the "County") passed Ordinance Number 2018-09 titled "An Ordinance Establishing An Enterprise Zone Within the County of Franklin" ("the Original Ordinance"). Said Enterprise Zone is within Franklin County encompassing contiguous portions of the Village of West City, the City of Benton, and the City of West Frankfort;

**WHEREAS**, pursuant to 20 ILCS 655/1, et seq., (formerly Ill. Rev. Stat. 1991, ch. 67 1/2, Section 601 et seq.) (the "Act"), the State of Illinois authorized the creation of enterprise zones, together with certain incentive programs;

**WHEREAS**, pursuant to the Act, the County created the Franklin County I-57 Enterprise Zone, which includes certain real estate located in the City of Benton, Illinois ("Benton"), the Village of West City, Illinois ("West City"), the City of West Frankfort, Illinois ("West Frankfort"), (the "Municipalities"); and the County of Franklin ("Franklin County"), (the "County");

**WHEREAS**, the Illinois Department of Commerce and Economic Opportunity ("DCEO") has approved and certified said Enterprise Zone pursuant to Section 5.3 of the Illinois Enterprise Zone Act, as amended (20 ILCS 655/1 et seq.) (the "Act"), to commence January 1, 2020;

**WHEREAS**, the County Board of the County of Franklin, Illinois has found it appropriate to amend Ordinance Number 2018-09 so as to amend and add territory to the Franklin County I-57 Enterprise Zone;

**WHEREAS**, the Municipalities and County have determined that it is necessary and in the best interest of the Municipalities and County, and economic development interests regionally, to amend the enterprise zone boundary to add property to the Franklin County I-57 Enterprise Zone, as described in Exhibit B;

**WHEREAS**, the Municipalities and County are requesting amendments to the Franklin County I-57 Enterprise Zone territory be made so the new property that is developed will receive all the state and local amenities provided by the present enterprise zone;

**WHEREAS**, a public hearing was held at 1:30 P.M. on Wednesday, October 6, 2021 at Franklin County Board Room, 901 Public Square, Benton, Illinois, 62812 where pertinent information concerning an amendment to the territory was presented,

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY BOARD CHAIRMAN AND COUNTY BOARD OF THE COUNTY OF FRANKLIN, ILLINOIS AS FOLLOWS:**

- (1) That the County Board of the County of Franklin hereby approves, subject to the concurrence of the Municipalities, and the Illinois Department of Commerce and Economic Opportunity; the expansion of the Franklin County I-57 Enterprise Zone to include the property identified in Exhibit A hereby incorporated by reference.
- (2) That the County Board of the County of Franklin, subject to the passage of comparable ordinances by the Municipalities and County, and subject to the approval of the Illinois Department of Commerce and Economic Opportunity, hereby approves the new boundary description of the enterprise zone as described in Exhibit B hereto.
- (3) That the County of Franklin will provide all local benefits and amenities in the expanded territory as is

currently being accorded to inhabitants of the Franklin County I-57 Enterprise Zone.

- (4) The County Board Chairman, if applicable, is authorized to execute an Amended Enterprise Zone Intergovernmental Agreement.
- (5) In the event any section or provision of this Ordinance shall be held unconstitutional or invalid by any Court, in whole or in part, such holding shall not affect the validity of this Ordinance or any remaining part of this Ordinance, other than the part held unconstitutional or invalid.
- (6) All ordinances, or parts thereof, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of their inconsistencies.
- (7) Nothing contained herein shall in any manner be deemed or construed to alter, modify, supersede, supplant or otherwise nullify any other ordinance of the County or the requirements thereof whether or not relating to or in any manner connected with the subject matter hereof, unless expressly set forth herein.
- (8) This Ordinance is effective upon its passage by the County Board, approval by the County Board Chairman, and publication according to law.

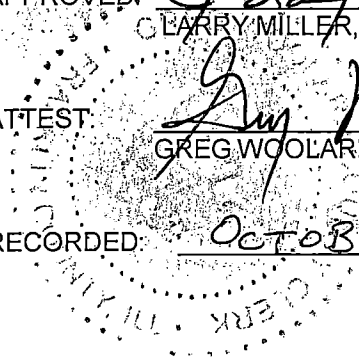

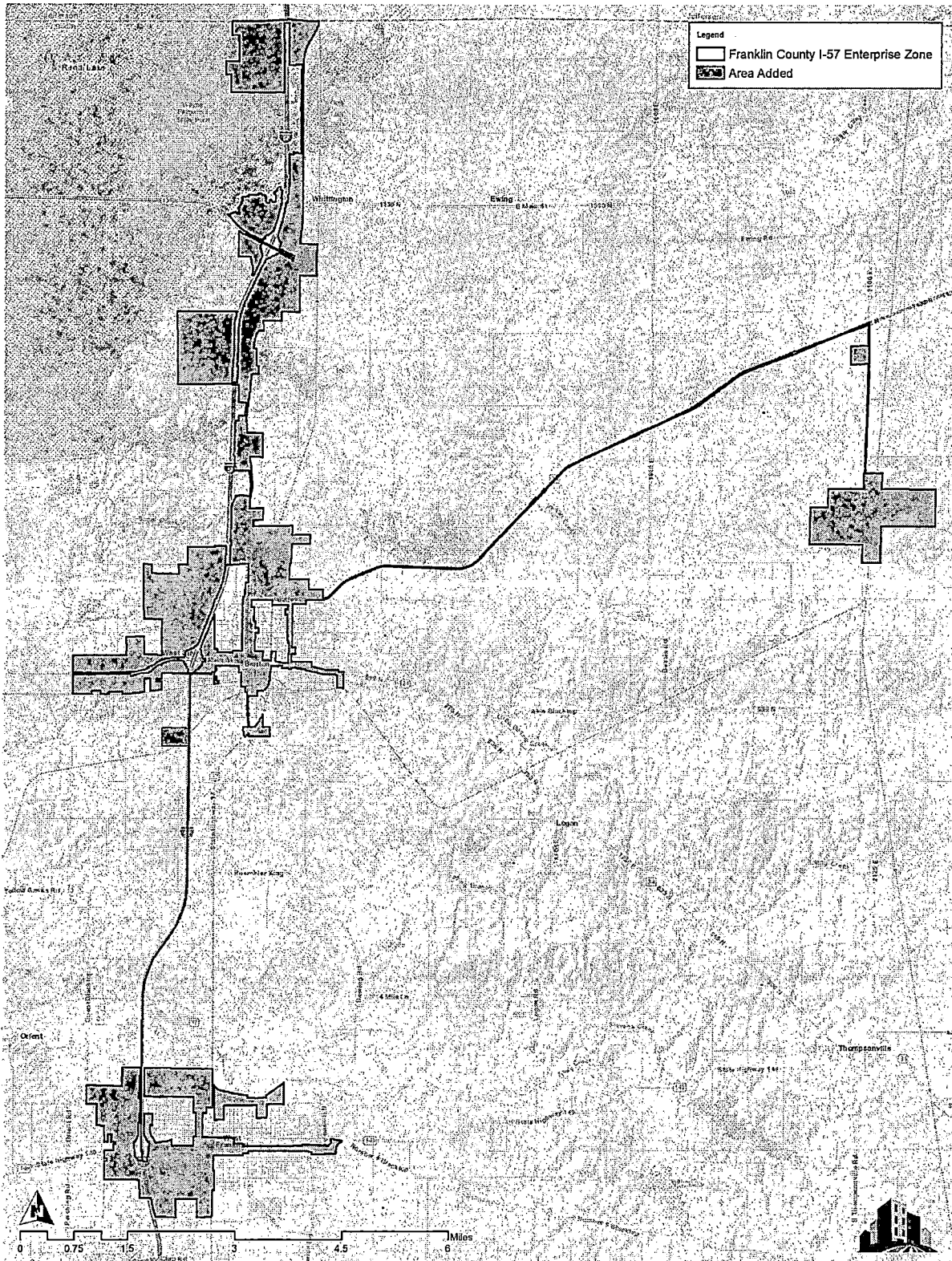
