MINUTES OF MEETING Feb 22, 2022

CALL TO ORDER

The Regular Meeting of the County Board was called to order at 6:00 p.m. by J. Larry Miller. meeting was held in the Franklin County Campbell Building, Courtroom A, 901 Public Square, Benton, Illinois.

ROLL CALL

Chairman J. Larry Miller asked the public if there were comments at this time. Tom Carter talked about how to give ARPA (American Rescue Plan Act) money to small water communities. He suggested the Macedonia Water District and presented information.

MEETING

MINUTES OF PREVIOUS Kevin Weston made a motion to accept the minutes of the January 18, 2022 Regular County Board Meeting Minutes. Ray Minor seconded the motion. call vote, all voted yes.

COUNTY CLAIMS

Ray Minor made a motion to pay the claims on file. Brad Wilson seconded the motion. On roll call vote, all voted yes.

DELINQUENT TAX PROGRAM RESOLUTIONS

Chairman J. Larry Miller stated that the first item on the agenda is the Delinquent Tax Program resolutions regarding authorizing my signature (J. Larry Wilson) to execute deeds on the parcels sold thru the County's Delinquent Tax Program.

Kevin Weston made a motion to accept the resolutions as presented. John Gossett seconded the motion. On roll call vote, all voted yes.

MOTOR FUEL TAX (MFT) LETTING FOR COUNTY & TOWNSHIPS RESOLUTIONS

Chairman J. Larry Miller stated that the next item on the agenda are the resolutions for 22-00000-00-GM Maintenance County and the 2022 Township Maintenance Section 22-000-00-GM and asked Mike Rolla, County Engineer to present these resolutions. Mike Rolla, County Engineer presented the County Maintenance the resolution for 22-00000-00-GM for material. Eagle Valley Inc from Shawneetown, Illinois for CA10 & Surfacing Material; Beelman Truck Co., East St. Louis, Illinois, for CA-16 and Seal Coat Aggregate; Emulsicoat from Urbana, Illinois for BIT.MTLS Liquid Asphalt and HFE-90/150 or RS-2 Delivered and Illini Asphalt, from Benton Illinois for Emulsified Asphalt Grade HFE-300 and BIT.MTLS Liquid Asphalt and HFE-90/150 or RS-2 Applied and HFP Applied all as the low bidders and he recommends approval.

Mike Rolla, County Engineer presented the second resolution is for the Township Road districts and they are as follows: Barren, Benton, Browning, Cave, Denning, Eastern, Ewing, Frankfort, Goode, Northern, Six-Mile & Tyrone. Awarding Beelman Trucking Co., East St. Louis Illinois, to furnish Seal Coat Aggregate CA 16; Illini Asphalt, Benton Illinois, to furnish BIT.MTLS Liquid Asphalt and HFE-150 or RS-2 applied, Seal Coat aggregate CA 16 applied and Emulsified Asphalt Grade HFE-300; Eagle Valley Inc. Shawneetown, Illinois, to furnish Surfacing Material CA 6/10; Dorris Trucking, Sesser Illinois, to furnish Surfacing Material CA 11; were

the low bidders. There are twelve townships and the resolution states which low bidder was awarded that contract and he recommends approval.

Kevin Weston made a motion to accept the resolutions as presented. John Gossett seconded the motion. On roll call vote, all voted yes.

STATE ATTORNEY'S LABOR CONTRACT -APPROVAL

Chairman J. Larry Miller stated that the next item on the agenda is the Collective Bargaining Agreement between Franklin County State's Attorney (Clerical) and the Laborers' International Union of North America, The Southern and Central Illinois Laborers' District Council and Laborers' Local Union 773 with the duration being December 1, 2020 thru November 30, 2023. Chairman J. Larry Miller states the terms stay the same.

Kevin Weston made a motion to approve the Franklin County States Attorney collective bargaining agreement. Mark Kash seconded the motion. On roll call vote, all voted yes.

Said agreement is made a part of these minutes as Agreement No. 2022-02.

CIRCUIT CLERK'S LABOR CONTRACT -APPROVAL

Chairman J. Larry Miller stated that the next item on the agenda is the Circuit Clerk's Labor Contract and this needs to be tabled at this time.

EASEMENT VARIANCE FOR FRAULINI SURVEY - APPROVAL

Chairman J. Larry Miller stated that the next item on the agenda is the Easement Variance for Fraulini Survey by Donald L. Bullard Land Surveyor. Mike Rolla, County Engineer explained this survey in the Committee meeting earlier this evening and asked for approval.

Brad Wilson made a motion accept the Fraulini Survey as presented. Ray Minor seconded the motion. On roll call vote, all voted yes.

Said survey is made a part of these minutes as document number 2022-0849.

PLACE AD FOR BIDS COURTHOUSE JANITORIAL SERVICE APPROVAL

Chairman J. Larry Miller stated that the next item on the agenda is the decision to place an ad for bids for the Courthouse Janitorial Servcie. Kevin Weston states he has called some local services and thinks the County should bid janitorial service for the new courthouse if feasible.

Kevin Weston made a motion to place an ad for bids. John Gosset seconded the motion. On roll call vote, all voted yes.

AMENDMENT TO LIQUOR LICENSE - CLASS A -ORDINANCE

Chairman J. Larry Miller informed the County Board that the next item on the agenda is the Ordinance for Amendment to the Class A Liquor License. Kevin Weston stated that he would like to increase the number of Class A Liquor License from six to ten. Brad Wilson asked about the process of getting a liquor license.

Kevin Weston made a motion to increase the number of Class A Liquor Licenses to ten. Ray Minor seconded the motion. On roll call vote the voting was as follows: Mark Kash, Ray Minor, Kevin Weston and Brad Wilson all voted yes. Randall Crocker, John Gossett, Neil Hargis, and Chairman J. Larry Miller all voted no. This being a tied vote the motion did not carry.

Randall Crocker made a motion to increase the number of Class A Liquor Licenses to seven. Neil Hargis seconded the motion. On roll call vote the voting was as follows: Randall Crocker, Neil Hargis, Ray Minor, Kevin Weston, Brad Wilson all voted yes. John Gossett, Mark Kash, and Chairman J. Larry Miller all voted no. This motion carried.

Said ordinance is made a part of these minutes as Ordinance No. 2022-01.

SHERIFF'S DEPARTMENT - PURCHASE 2 SQUAD CARS

Chairman J. Larry Miller stated that the next item on the agenda is the purchase of two squad cars from the Sheriff's Department. Sheriff Dave Bartoni asked to purchase two new Dodge Durangos around \$50,000 dollars per car and he is asking to get the money from the ARPA (American Rescue Plan Act) Funds.

John Gossett made a motion to approve the purchase of the two cars as presented. Mark Kash seconded the motion. On roll call vote, all voted yes.

WHITE & BORGOGNONI ARCHITECTURES

Chairman J. Larry Miller stated that the next item on the agenda is the White & Borgognoni Architects, P.C. for architectural / engineering services in the amount of \$19,099.10.

Ray Minor made a motion to approve the payment to White & Borgognoni Architects, P.C. Brad Wilson seconded the motion. On roll call vote, all voted yes.

NAVIGATE PLANNING SOLUTIONS

Chairman J. Larry Miller stated that the next item on the agenda is the Navigate Building Solutions for January 2022 owner representative services in the amount of \$16,500.00.

Ray Minor made a motion to approve the payment to Navigate Building Solutions. Brad Wilson seconded the motion. On roll call vote, all voted yes.
