Chairman Minor asked for the county claims to be submitted to the board, which were then approved and signed by all members present.

After presenting the current claims, Treasurer Steve Vercellino gave his report including...

- ESS Voting Equipment had been paid \$351,065, which will be paid by ARPA funding.
- 43 more current and/or past employees will be paid Premium Hazard pay the next week approximately \$277,200, which will be paid by ARPA funding.
- We currently have approximately \$2.6M ARPA funds.
- 2/18/2022 General Fund ending bank balance is estimated to be \$4,313,774.

Chairman Minor mentioned that the previous report given does not address what is owed to various departments. County Board Chairman Larry Miller mentioned that due to the change in restrictions on the ARPA funding, the county will be able to solve some long-time shortage problems to the budget. Discussion followed and the board would like to see a plan to repay those department accounts, which will be presented at the next Finance committee meeting.

Dave Schmitt and Mike McCollum were present to request additional Class A Liquor License be added. McCollum has purchased an area on Licatta Drive. The intent is to open a general store, (including hunting and fishing equipment) liquor sales, gambling machines, camp sites, and at least (2) BNB's. Discussion followed and increasing the amount of Class A Liquor License was requested to be on the next agenda (February 22, 2022).
