Vice Chairman Brad Wilson asked Judge Melissa Morgan her opinion on the 2022 Franklin County Juvenile Detention Center Inspection Report, which can be viewed on www.franklincountyil.gov as 9-19-2022 Public

Safety Meeting Attachment 1. Judge Morgan felt there was several incorrect statements in the report and/or those areas had already been addressed, for example...

- Salaries for officers is now at \$43,000/annual salary
- Supervisors are now \$48,000/yearly salary.
- The state will now reimburse the county for part-time employee's salaries. This will help with maintaining staffing levels.
- Education for the juveniles is in process.

Sheriff Bartoni then mentioned he had spoken to another company that might be able to help with the water issues in the County Jail. It is a totally different approach than the previous company had provided and he will be receiving a second quote to discuss.

Coroner Marty Leffler presented his report...

- 2 Covid deaths this past month. His full report will be accepted during the County Board meeting and posted with the attachments.
- He also spoke about his need for a better way to service Franklin County as coroner. He is currently having to take bodies to O'Fallon if a pathologist is needed.
- He then discussed the problems he has with lack of storage, the cost to use storage from other counties,
 etc.

Vice Chairman Brad Wilson suggested to him, to try to get information on the cost of a morgue. Discussion followed on the possibility of building a morgue. There could be a way to generate revenue from other counties.

Chairman Gossett then mentioned that Animal Control has an employee leaving in December that will need to be replaced.

Board Chairman Larry Miller told the board he would have several appointments for the following Board meeting. He also told the Board he would have to table the item on the agenda - Repaying County Highway Bridge Fund.
