The meeting was call to order at 5:21 PM by Chairman Kevin Weston.

County Highway Engineer Mike Rolla was asked to present county highway's claims to the board and give his report...

- County Highway Contract is on the agenda for approval.
- He will be posting information on Facebook and the website for applications for a mechanic. Applications are available at the County Highway office or through email.
- Work on Creek Nation starts next Monday, September 26th.
- Sesser Pave and Seal has completed the "Stop Ahead" thermo plastic on Park Street Road. County still has signs ordered for the intersection.
- Had spoken to Chastain Associates and 911 Director Amos Abbott about our need for road signs throughout the county. He did point out that first responders do have mapping in their vehicles. It could cost as much as 1/2M to replace all the signs.
- Macedonia Road could be experiencing road subsidence, due to underlying coal mining areas, the first part of October.
- He has submitted several areas to IDOT that still need asphalt work done...including Peach Orchard Road, Webb Hill Road, Log Cabin Road and Yellow Banks Road.

Chairman Weston gave his report...

- He is currently getting a quote for copier/printer for Animal Control
- He is recommending HSG Mechanical for HVAC maintenance at the Courthouse. This will be on the following County Board agenda.
- He and Sheriff Bartoni had viewed one system for water valve control and will be getting another quote to help with water usage in the jail area.
- Bathroom problems in the Circuit Clerk's area has been resolved.
- Dehumidifiers are needed for the Campbell Building basement
- Walk through will be done next Friday at the Courthouse with WBA, Fager-McGee and Navigate.
- He will also be recommending Vaughn's Roofing to repair sky-lights at the Juvenile Detention Center and it is also on the following County Board agenda.
