July 1, 2024

In early 2023 I reported to the County Board and requested funding for the addition of a second K9 to be supported by Opioid Abatement Settlement Funds. At that time I provided the following statistics related to drug activity in Franklin County. The board soon voted to fund the project in the amount of \$24,000.00.

\*Feb. 2022 - June 2023:

K9 Incidents - 62

Methamphetamine Seized - 1,293.7 grams (Street value @ \$60.00 p/g = \$77,622.00)

Currency - \$64,075.00 (SIDTF)

Since adding the additional K9, the Sheriff's Office, in cooperation with the SIDTF and other Franklin County Municipal Agencies has generated the following statistics.

\*June 2023 - June 2024:

K9 Incidents - 134

Methamphetamine Seized - 2,623.44 grams (Street value @ \$60.00 p/g = \$157,406.40)

Fentanyl Tablets Seized - 270 (Street value @ \$25.00 p/p = \$6,750.00)

Cocaine Seized - 40.86 grams

It is my request that additional funding from the opioid abatement settlement be made available to add a third patrol K9 to the Sheriff's Office. I understand that this program is costly, but I am also keenly aware of the cost that our communities and county are suffering as a result of the drug pandemic. I have discussed this request with States Attorney Dinn and she has expressed her support of this additional K9. I am including an itemized list of associated costs related to the addition of the K9. I appreciate your consideration of this project and am available to answer any questions you may have.

Members of the Franklin County Board,

As you are aware, illegal drug use is a great issue in our county. Few families exist that have not in some way been negatively impacted by this nationwide crisis. As a recipient of Opioid Abatement Settlement Funds, the Franklin County Board has made great decisions in the use of this money. As you recall, during the first round of funding in early 2023, four projects were chosen by the board to financially support. They included the addition of a single purpose K9 for the Sheriff's Office (Feb. 2023), Take Action Today (treatment and recovery \$25,000), Franklin County CASA (treatment services - children \$10,000), and the Benton Police Department (investigative data software \$4345.00). The decision to spread funding among law enforcement and treatment / recovery services was, in my opinion, both reasonable and responsible and undoubtedly meets the intended use of the settlement agreement.

In early 2023 I reported to the board and requested funding for the addition of a K9 to be supported with Opioid Abatement Funds. At that time I provided the following statistics in support of the project and it was funded by the board in the amount of \$24,000.00.

\* Feb. 2022 - June 2023 Activity:

K9 Incidents: 62  
Methamphetamine Seized: 1,293.7 grams (street value @ \$60.00 per gram - \$77,622.00)  
Currency: \$64,075.00 (SIDTF)

Since that time, the Sheriff's Office has had two working K9's on our schedule. The handlers and dogs work closely with the Southern Illinois Drug Task Force as well as all municipal departments within Franklin County. Our policy is to accommodate, as best we can, all requests for the K9 not only for Sheriff's Office Patrol but all other police agencies working within Franklin County. We currently have K9 staffing 80 hours per week, however, that is only half the time of a 24/7 weekly schedule. The last 12 months have produced the following numbers:
