**Opioid Abatement Funds Request:**

For the last 15 years the Sheriff's Office has been fortunate to have specialized equipment such as Cellebrite Digital Intelligence that has been paramount to investigations involving drug trafficking, child abuse, sex cases involving both children / adult victims, and motor vehicles crashes involving death. Upon the retirement of Detective Minton, we no longer have a certified operator of this specialized investigative tool.

I am requesting Opioid Abatement Funds in the amount of \$6,020.10 in order to send Detective Amy Tipton to complete this specialized training and become certified in the use of the Cellebrite device.

We have checked with Cellebrite on locations of training with the closest session being held in Nashville, TN from DEC. 4th - 8th.

**Cellebrite Training and Equipment Costs:**

1. Cellebrite Certified Operator (2 days) - \$1,700.00
2. Cellebrite Certified Physical Analyst (3 days) - \$2,500.00
3. Cellebrite Equipment Update - \$730.00
4. Travel / Lodging Expense (Nashville, TN) - \$1,090.10
