Establishment and Overview

The Veterans Assistance Commission (VAC) of Franklin County was officially stood up on December 1, 2023. The VAC is staffed by one Accredited Veteran Service Officer (VSO), who also serves as the Superintendent, Mr. Liam Mungovan. After acquiring accreditation and the necessary Personal Identity Verification (PIV) card from the Department of Veterans Affairs, the VAC began filing claims in late February 2024.

The VAC's mission is to provide compassionate support and effective advocacy for Franklin County's Veterans and their families, ensuring they receive the benefits and assistance they deserve.
