Opioid Abatement Funds

1. The Franklin County Sheriff's Office has developed drug treatment / life skill programming for inmates incarcerated at the Franklin County Jail. The program includes the placement of a TAT representative within the jail facility to facilitate the program. As a result of the program, the Sheriff's Office redesigned an unused visitation room and converted it into a classroom and office. Approximately \$10,000.00 was used to complete this project.
2. In February of 2022 the Sheriff's Office added a dual purpose K9 to patrol. This K9 purchase was based on a partnership with the Southern Illinois Drug Task Force. SIDTF contributed \$15,000.00 for the purchase of the K9 and training. FCSO provided the specialized vehicle and required equipment. Since the inception of the K9 program, great results have been achieved:

K9 Incidents: 62

Methamphetamine Seized: 1,293.7 grams (Street Value: \$116,370.00)

Cannabis: 65.8 grams

Currency Recovered / Located: \$64,075.00

Request for Funding: Methamphetamine use, in my opinion, is the greatest challenge facing public safety in our county. This drug abuse epidemic is directly related to many other crimes including, thefts, burglaries, crimes of violence, and the abuse and neglect of children. I believe that we must combat this issue from multiple directions, to include strict and aggressive enforcement of the law. I also believe that we can't arrest our way out of this issue. As a result, I believe that we have some responsibility to offer a level of treatment within the jail setting. Through our partnership with Take Action Today we are doing just that.

I am requesting Opioid Abatement Funds in the amount of \$34,000.00. This funding will be directly related to the opioid epidemic faced throughout our county. \$10,000.00 will be utilized to pay for the treatment facility / classroom established within the jail. The additional \$24,000 will be used to deploy a second, single purpose, narcotics K9 to be assigned to a patrol Deputy.

States Attorney Dinn and I are working on other options for the additional money within the fund.

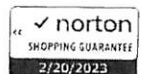
