NOVACOM INC. DESCRIPTION OF SERVICES FOR PROPOSED I.T AGREEMENT 4-03-2023

Novacom will include all labor 24-7/365 under this agreement, there will be no extra labor charges for after hours or holidays.

This agreement includes the maintenance of all protected devices in the sheriff's department and Jail. This agreement includes the maintenance of all Avigilon video products and its current and future addons.

This agreement will include the Franklin County EMA Telex I.P Dispatch single position, due to the fact that all positions need to be functional for public safety to do their job.

The remaining 3 positions are covered under the Franklin County 911 agreement. The addition of this position does not add extra cost to the I.T agreement,

nor will there be any additional charges to the Franklin County EMA for this additional maintenance. This agreement includes the maintenance and communication with all vendors and service providers of the functioning sheriff's department and jail.

This agreement includes maintenance of the radios in the dispatch radio room and antenna systems located at the Sheriff's department location.

This agreement does not include the labor or maintenance of squad car radios, officer handheld radios, squad car lighting, squad car cages and guns mounts.

This agreement does not include the labor or maintenance of the existing repeater system and it's infrastructure.

The Novacom/Motorola warranty for the new sheriff's digital system includes repeaters, radios, and portables, they will be covered under the 5 year warranty provided with the radio purchase.

While this agreement does include labor and maintenance, it does not include the replacement of defective, damaged, or environmental acts causing damage to equipment, parts and materials needed to maintain the systems, and does not include the purchase of new equipment.

This agreement includes 45 licenses of annual endpoint security called Sentinel One, this protects devices from many types of online threats and includes up to \$1,000 of endpoint insurance per device, to repair or replace a device that has taken damage due to an online threat that is protected by Sentinel One.

This agreement does not auto-renew on April 1st, 2026, if the Franklin County sheriff would like to extend the services provided by Novacom, a revised agreement will be provided at that time.

ADDITIONAL SERVICE NOTE:

I have made the start time for this agreement 4-01-2023, if we provide you with services between now and your board approval to this agreement, the labor will be covered under this agreement, if the board chooses not to approve this agreement, we will bill for services on our hourly, standard, non-contract rate.

NOVACOM INC. TERMS AND CONDITIONS FOR TERMINATION OF CONTRACT 4-03-2023

VENDOR OR CUSTOMER TERMINATION:

if at any time in the proposed agreement, the customer feels that Novacom is not providing services that meet the requirements and needs requested by the customer, the customer can terminate this agreement without any financial penalty. Novacom does request that the customer provide a 30 day notice prior of the termination. If the customers pays quarterly, semi-annually, or annually, and terminates the agreement, a refund will be provided to the customer reflecting the time remaining that has been paid but, will no longer receive services:

If the customer can no longer fulfill the financial obligations, Novacom will work closely with the customer due to the services provided by the customer, to make sure the customer can still provide the services needed for public safety and still receive the services provided by Novacom. If both Novacom and the customer have exhausted all resources and cannot reach a mutual agreement, the agreement can be terminated.
