This install will require that the controllers be mounted on the roof in line of sight with each other. To achieve that we will need to run the wires through the parapet wall to attach it to the lights. Creation of the access ports will need to be made prior to our install.

The manufacturer's warranty with your new Inception Lighting system covers the lights, jumpers, controller, gateway and power supplies for the first 3 years, and the base and lid for 5 years. The "Color Care" Extended Warranty Plan provides 100% peace of mind coverage on all

component and labor costs associated with warrantable failures in the electrical components for 5 years and the attachment hardware for 10 years.

Benefits of the "Color Care" protection plan:

- The Protection plan is paid annually. (price varies on location and accessibility of lights). This will increase the components (light strands, jumpers, transformers, repeaters, power supplies, controllers and gateways) replacement from 3 years up to 5 years and from 5 years up to 10 years on the base and lid.
- Covers repair and replacement labor costs on all warrantable parts of the Inception Lighting system. (\$200 service call fee may apply)
- Service work completed by a certified Inception Lighting technician.
- Ongoing control system training and phone support.
- Firmware updates and system checks to maintain optimal performance.
- Due to the height of the building and accessibility of the lights, we will have to add the cost of renting a lift if we need to get to the lights themselves. Current price for the lift needed is \$1500 per day (price may vary)

What is covered:

The entire system including base, lid and attachment hardware, light strands, jumpers, transformers, repeaters, power supplies, controllers and gateways, and digital backhaul devices if applicable.

What is not covered:

Service calls for tripped GFIs or other client caused power issues. Service calls for connectivity issues due to client's internet failure or network changes. Service calls or components for damage done to the system during remodeling, painting, reroofing, construction work, or vandalism.

(These types of calls may incur a \$200 Service Call fee.)

Man-made disasters, lightning, and other "Acts of God" are not covered by any warranty. Damage or material failures due to abuse or negligence are not covered. Any tampering or attempts to fix any problems with, or to alter any part of the lighting system, whether by the building owner or anyone not employed by Judge Services, will void all warranties.
