## AGREEMENT NO. 2023-04 SECOND AMENDMENT TO EMERGENCY MEDICAL SERVICES AGREEMENT

THIS SECOND AMENDMENT TO EMERGENCY MEDICAL SERVICES AGREEMENT ("Amendment") is entered into as of June 19, 2023, but effective as of May 31, 2023 ("Effective Date") by and between Mission Care of Illinois, LLC dba American Medical Response ("AMR"), and Franklin County, Illinois ("Agency"). AMR and Agency are sometimes collectively referred to hereafter as the "Parties" and individually a "Party".

#### **Preliminary Statement**

- A. AMR wishes to amend the Emergency Medical Services Agreement that was entered into on April 1, 2022, and first amended March 1, 2023 (collectively, the "Agreement");
- B. The parties agree to amend the Agreement on the terms and conditions set forth herein.

#### Agreement

In consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties incorporate the above recitals and agree as follows:

1. The parties hereby make permanent the operational changes reflected in the First Amendment and outlined again below.

AMR must dedicate a minimum of the following: Two (2) Advanced Life Support (ALS) ambulances 24 hours per day, seven days per week dedicated to emergency 911 services and emergent requests originating within Franklin County. AMR will prioritize Franklin County PSAP/Emergency Communications Center requests above private requests within the county by reserving one ambulance to be available for emergency requests; nor will AMR drop to status zero for non-emergent in county requests. AMR may choose to utilize dedicated ambulances on non – urgent in county requests when two units are available. Non-urgent requests placed on these units must be limited to transports that have both pick up and destination within the County of Franklin. AMR may staff additional ambulances above the required amount at their discretion and utilize those additional units within the 911 response system during times of increased demand providing they meet the requirements set forth by the agreement. AMR must maintain the capability to call back personnel and surge additional ambulance units into the 911 system during major emergencies and disasters.

2. All other terms of the Agreement remain unchanged.

By signing below, each party acknowledges that he/she has carefully read and fully understands this Amendment to the Agreement, and each agrees to be bound by the terms of this Amendment.

Fiddler's Green Circle, Ste 1400 Greenwood Village, CO 80111 We are asking for the county to amend the contract to allow AMR to have 2 dedicated ambulances instead of 3 for the next 90 days. Currently with three dedicated trucks to Franklin County 911, the business unit in a position that is not financially sustainable.

#### How did we get here?

- 281% increase in employee cost per transport from 2013-2022 The shortage of employees starting in 2020 and the market dictated the salary increase.
- Less than 1% increase in volume from 2013-2022, we are not seeing volume growth as anticipated. Budgeted UHU of 15.8% and actual is 12.5%
- Budgeted for trucks to be busy (TUHU) 15.8% of time and actual is 12.5% of the time in 2023
- In 2019 and 2020 we had negative growth in volume, across the nation we are not seeing the 911 volume return to pre covid numbers as anticipated.
- In 2020 and 2021 AMR had cares dollars and FEMA dollars from deployments that helped sustain the operation, those dollars are gone.
- In 2022 when contract was signed, AMR added a fourth truck to try and gain additional volume outside of Franklin County to help support the Franklin Operation. The volume never materialized as anticipated.
- Increase in self Pay patients, has decreased our reimbursement for the past two years. We have increased billed amount but are seeing less collected. Currently we are at 2019 reimbursement levels with 1865 less transports. Average Self pay is \$215
- We are deploying 7,877 hours more than in 2013. This equated to almost one additional truck 24 hours a day
- At the end of the day, we are price takers. 80% of our volume is Medicare and Medicaid. These pains are especially profound in smaller rural systems because those BUs (low volume) are so sensitive to cost fluctuations.

#### **Develop Best Reasons**

- Allowing us to free up the third dedicated truck will allow us to get volume outside of Franklin County that will help sustain the Franklin County operations
- 97% of the time two trucks is enough to support the region.
- AMR has mutual aid agreements with surrounding departments that can assist when all trucks are on calls
- We will trial this for 90 days, staying in constant communication with EOC Director, making sure the two trucks can sustain the local 911 volume
- If County is not happy with service at any point in the 90-day trial, or at the end of the trial. AMR will support the county issuing an RFP for 911 services in Franklin County
- Show the county the language that we are proposing.

We have refined the process of how we schedule and staff our ambulances to position ourselves better to mitigate losses

We have successfully implemented a sustainable response plan that has achieved improvement financially

Since end of January, 2023 we have successfully mitigated many of our loses bringing the business unit back to being closer to financially solvent

#### Operations

We are staffed to meet our contractual minimum requirements at this time.

We have seen an increase in the number of times that we are status 0 as we expected. We are servicing over 99% of the Franklin County requests at this time.

#### Issues/Concerns

Franklin County Sheriff Office continues to fail to call the East Regions Communications Center by phone to provide call information.

#### **Financial Stability**

The Franklin Operation has remained financially solvent for the past couple of months. We are no longer expericeing significant financial loses.

#### Operations

We are staffed to meet our contractual minimum requirements at this time.

We have seen an increase in the number of times that we are status 0 as we expected. We are servicing over 99% of the Franklin County requests at this time.

In the past two months we have been able to successfully onboard two EMTs and two Paramedics. This will afford us a more reliable ability to staff a third unit.

#### Issues/Concerns

Franklin County Sheriff Office has improved in calling the East Regions Communications Center by phone to provide call information.

#### Franklin SOPs

- Local is defined as any trip originating and terminating inside of Franklin County.
- Long Distance ('LD') is defined as any transport more than 70 miles.
- Contact Franklin SO via radio when status 0.
- If BLS unit is available, it may be utilized on 911 calls. BLS units may request ALS intercepts or QRV response from on duty Supervisor
- We will only respond to mutual aid requests for transports, we do not provide venue coverage for any other department.
- The Ops Sup has the discretion to rotate crews or reassign transfers as necessary. They will do so by sending written correspondence to the Communications Supervisor group and "Franklin Marion Transfer Requests" to ensure handoff of information between leadership groups from shift to shift.
