Treasurer Steve Vercellino gave his report...

- Beginning Balance is \$8,627,186. ARPA balance is \$4,480,332.54, not much change from last month. Estimated ARPA after EOC is completed will be \$581,332.54.

- In the process of reconciling July bank statements.
- Report shows a few checks as "not new". Had a few checks that have not been cashed and getting old. Stopped payment on those and issued new.
- Heavy traffic today with payment of Real Estate tax bills. Part time employees are back to help. One of the part time employees has helped during the tax time before. There is also a new one who seems to be picking it up very well.
- Board Member John Gossett asked about a claim from the County Clerk concerning Blue Cross Blue Shield. Vercellino explained that the County Clerk's office creates the claim for the county. He, as Treasurer, processes it.
- Board Member Curtis Overton asked about a claim to ArchImages for the EOC- is this beyond what we are spending at the EOC? Board Member Kevin Weston explained the claim. This is part of their fee for designing the building, overseeing general contractor, and handling construction documents.

## Chairman Larry Miller...

- Budget seems to be on track except for a few areas of which we were aware.
- We should be getting the audit soon. We are needing the info from that to work on 2025 budget.
- Assessments for Real Estate seems to be up. But we need consistency on our assessments throughout the county.
- Discussion then followed about how we could get that to happen.
  - 1. Most townships have their own assessors, which makes the subjective part of assessing hard to accomplish.
  - 2. Possibly go to each township and talk about the assessments and how to make it more across the board.
  - 3. How to reassess every 4 years.
  - 4. Appoint a group to talk and explain the problems to the townships.

Board Member Kevin Weston asked Circuit Clerk Jim Muir when the scanning will be done. Muir explained that there are many years of documents still to be scanned, and this project is a very important project for the people of the county. He has 2 part-time employees working on this project. He is planning on putting this in his 2025 budget in order to continue the job.
