- Phone numbers are listed for information on the routes.
- SCT is growing rides are also available to the hub in Marion which can then take you to other areas.

The meeting was called to order at 5:27 by Chairman Kevin Weston. See above lists of those attending and the subject of those stating public comments.

Matt Barnett, County Highway Engineer, was asked to present county highway's claims to the board and to give his report...

- Mine 21 Resurfacing Project had a pre-construction conference last week. IDOT will begin late September and should be a quick project. Probably done in October.
- A bridge on Willis Road is to be replaced. There will be a letting on August 29th. This project will be 100%payed by the state. In the past, the state had paid 80/20% with the townships for bridges. The state will now be covering 100 % funding for the township bridges. County and the Townships should no longer have to use their funds.
- He has a resolution from the state that is on the agenda for the following County Board Meeting for resurfacing parts of Yellow Banks Road to use RBI funds for 1.61mile of the road.
- Akin/North Thompsonville have coal mines using their roads. The mines are supposed to take care of the damage to use the roads.
- Train crossings are in bad shape. Some of the problems have been turned into Burlington/Northern/Sante Fe Rail Way.
- Another problem on that is when we redo a road, we have to stay so away from the tracks. Then it seems to take quite some time for the crossings to be fixed.

Chairman Weston...

- Tomorrow Marion Glass will be at the Campbell Building to install the bullet-proof glass for several departments in the building.
- A couple more offices are needing to have some changes made in how the offices are arranged before installing the glass in their areas.
- Loyd Electric has given us a cost for the changes we need for the phone systems in the Justice Center. That quote is on the following agenda for approval. Also on the agenda is the quote from ClearWave concerning the phone system also.
- He and Board Chairman Larry Miller had a conversation with Benton mayor Lee Messersmith about a problem that the city is having in their city hall. Some of those who work for the city will be housed in the former Courtroom A in the basement of the Campbell Building until the city's problem is resolved. Discussion followed.
- Told the board that he has 2 other agreements on the following County Board agenda. He would like for the board to approve 1 of the agreements

Board Member Curtis Overton...

- Was concerned about parking space with the City Hall employees that will be in the Campbell Building.
- Was still trying to get a way to have one of the poles removed or at least moved that is in the parking area at the Campbell Building.
- At this time the ideas have been quite costly.
- He is still looking into another idea, but this has not been resolved at this time.

Circuit clerk, Jim Muir...

- Happily told the Board, that techs from Judges, would be at the courthouse the next week to begin the installation for the special lighting on the Courthouse.
- It will only take a week to get all set up.
- Training for using the lighting, will also be given next week.
