- At a coroner's meeting the last week several counties showed an interest in our upcoming facility.
- Our cooler will be able to take care of 12-15 bodies.
- He brought up the fact that the salary for the coroner has not changed in 5 years. It would have to be decided prior to 180 days before the election for a coroner. It's currently a little under \$37,000. Other rural counties in Illinois are around \$55,000.

- Commented that our Coroner is a great asset in death investigations.
- Thanked the board for allowing his department to use surplus vehicles for trade-ins.
