The meeting was called to order at 6:02 by Chairman John Gossett. See above lists of those attending and the subject of those stating public comments. Gossett then asked for any reports.

Sheriff Kyle Bacon...

- Gave his Monthly report which can be seen on www.franklincountyil.gov as 7-1-2024 Public Safety Committee Meeting Attachment 1
- This report included the statistics of a second K-9 that was requested and approved in early 2013, and with cooperation from the SIDTF, and other Franklin County Municipal Agencies, since that time the successful use of K-9's has more than doubled.
- Bacon requested a third patrol K-9 to be added to the Sheriff's Office. The financing will again be through money received by the Opioid Abatement Settlement Funds. This request will be on the July 15th County Board Agenda.
- Bacon then explained the current "per day cost" of Federal inmate holding is \$60.00 per day and he has requested an increase to \$85.00 per day. Increase in food and in labor has allowed most jails in our area to successfully negotiate this increase. He will keep the board informed.
- His report also included monthly jail healthcare information.
- At the current time, a nurse to handle and distribute medication (new scripts/script refills/etc.) is in our facility only 20 hours/week and he would like to find a way to raise this to 40 hours/week.
- Board member Brad Wilson asked Bacon if he had anyone reaching out to use for use of the vacant JDC. At this time that is not happening.
- Ideas were discussed about possibilities, but nothing is moving at this time.

Chairman Gossett then commented on the fact that CASA is also in need of financing from the Opioid Abatement Settlement Funds. It was discussed about how many families and children have been hurt through drug abuse and how much CASA has helped. Coroner Marty Leffler...

- Would still like to have an open house, but a date hasn't been decided upon yet.
