Circuit Clerk Jim Muir explained about a program In-Lingo...

- About a year ago The State Administrative Office required his office to provide interpretation through a program named In-Lingo for those who need it while in Zoom Court.
- The state freely provided In-Lingo for the county court system with good and timely results.
- The need for interpreters has risen from approximately 4/a year and now up to 6/a month.
- The State will no longer be providing the service for free. Cost of the In-Lingo interpreter service is \$120/hour.
- At one time local residents that could speak a second language were used for those who needed an interpreter.
- Interpreters now also have to be certified through the state and there is quite a fee to become certified.
