Sheriff Kyle Bacon...

- Discussion followed concerning the School Resource Deputies. 104 hours per week of the time the officers are at the school is being reimbursed by the schools.
- He is still in the process of increasing the "per day cost" of federal inmate holding.
- Also still working on changes for the healthcare of the inmates.
- Talked to the board about a type of x-ray body scanning machine that would be of value for the safety of the officers and also the inmates. Cost of the machine is around \$150,000. Discussion followed.

Chairman Gossett asked for reports....

Sheriff Kyle Bacon...

- Mentioned that he is currently 80% over his budget.
- This has been due to overtime, fuel prices, health care for inmates.

Coroner Marty Leffler...

- Has one of his staff retiring September 30th.
- The Pathologist has been back and he brought lots of supplies he uses. That's a good sign that he does like our facility.
- He has sent pictures and information about our Coroner's office to coroners in other counties.
- He mentioned that today is the 1 year anniversary for 3 local teenagers that died in a car wreck.
- He also asked for prayer for his wife Alisa. She has a grapefruit size solid mass and it is causing a lot of pain on her back. Will be going to see an oncologist Friday in St. Louis.

Chairman Gossett asked Animal Control Supervisor Bobbie Williams about a second quote needed for repair on the Animal Control area. She did have that quote for tonight's County Board meeting from FW Electric for \$9,530.00.

EMA Director Ryan Buckingham (on Phone) gave his report...

- Time of the year for visiting towns to discuss weather preparedness. EMA was at Maid Rite in Christopher this past Saturday.
- Safety days coming up in October.

County Board Chairman J. Larry Miller...

- Budget meetings will be starting soon.
- If board members are interested in the Resolution concerning immigrants, please let him know and it will be on the October Agenda
- He has put together a letter to be in the next payroll, requesting those employees who have insurance through the county, to fill out a questionnaire that is also included.
- The Board is trying to give employees a good health provider as they have now, and also to keep cost down for the county.
- Is doing some investigation about solar farms, and, if needed, to be sure that the county is covered.
- The meeting with Township Supervisors went well.
 - 1. He and Supervisor of Assessment Cindy Miklos had explained to them about the problems created throughout the county with assessments not being consistent.
 - 2. He assured the supervisors that we are not trying to get rid of township government.
 - 3. There is a motion on the following agenda concerning hiring an assessor to work in various areas of the county.
 - 4. The assessor would not be looking for properties that are already assessed but properties that have not been assessed.

Chairman Gossett will be looking into wages for parttime employees...

- January 2025, minimum wage does go to \$15.00/hour.
- He would like to see if the county could do better than that.
