Opioid Abatement Funds:

Franklin County has been fortunate to be a party in the "National Opioid Lawsuit". It has not only benefited the Sheriff's Office but also numerous municipal departments throughout the county. I am thankful to S/A Dinn for her involvement in ensuring that Franklin County receives appropriate monetary awards as a result of the settlements. These settlements with manufactures and distributors of opioids are ongoing and I expect further funding to roll in as the cases are resolved.

Approximately 9 months ago, K9 Riot, was medically retired as a result of a heart condition. His retirement left the Sheriff's Office with two remaining K9's. It also vacated a K9 vehicle outfitted with approximately \$15,000.00 of specialized K9 equipment. It is my desire to utilize opioid funds to purchase a new K9 to replace Riot. I have attached a quote in the amount of \$14,388.00 from Vohne Liche Kennels, Inc. for your review.

Both S/A Dinn and I have been in communication with the West Frankfort Police Department who has requested financial assistance with the purchase of their first K9. They are in the process of fund raising to help cover equipment costs. It is my understanding that a proposal will be made at a later meeting for the board to consider their request. To date, both the Benton Police Dept. and Sesser Police Dept. have received opioid funds from Franklin County for qualifying projects.
