## MINUTES OF MEETING

Jul 21, 2025

---

### CALL TO ORDER

The Regular Meeting of the County Board was called to order at 6:00 p.m. by Kevin D. Weston. This meeting was held in the Franklin County Courthouse, County Board Room 133, 100 Public Square, Benton, Illinois.

### ROLL CALL

**STATE'S ATTORNEY TO  
ENGAGE OUTSIDE  
COUNSEL FOR  
INTEGRITY LAWSUIT -  
RESOLUTION**

Vice-Chairman Kevin D. Weston stated that the next item on the agenda is the approval of the resolution for the State's Attorney to engage outside counsel for the purposes of representation and litigation and to authorize payment for representation in the Integrity Lawsuit.

Angela Evans made a motion to approve the resolution as presented. Dave Bartoni second the motion.

Vice-Chairman Kevin D. Weston asked if there were any discussions.

Curtis Overton: I haven't heard much about this. Is this where that several counties in Illinois are being sued?

Dave Bartoni: I mean 40. Yes. 40.

Curtis Overton: And this is an order that she can get outside representation for the county said she can't do it herself.

Angela Evans: Yes. Okay. I understand. Thank you.

J. Larry Miller: I can ask. I should know, but I've forgotten the basis of the suit what is it?

Steve Vercellino, County Treasurer: Yeah. So as far as the suit, so it was a Supreme Court ruling said as far as the Tax process, all the states, you should handle it this way. There's amount money that you collect as far as the tax sale process. They're saying there's a piece of it that is basically the sweat I believe that you may have in your house if you lose it on taxes. But we get everything and we sell to whoever was different between that piece. They're saying, well, they should even, they know they lost the house, the taxes. They shouldn't lose the sweat equity. I know that's an open generalization of it. A lot of states changed laws based on that get done. And so, like myself and Kevin and all the other county special, we're following what state law says, which is, doesn't quite follow what the federal law says.

So, all the counties and all are multiple lawsuits. There's one down here and I think one more up north where we're all getting sued for the

same thing basically. And unfortunately, it is a federal thing, so I really can't handle it. I believe policy has an exclusion that says that they can't handle it either, which is not just this company or the company that we're going to. It going to be the same situation. So, all the counties are having to get something representation for this.

J. Larry Miller: So loosely what does it mean?

Steve Vercellino, County Treasurer: I don't know it's going be probably several years. I expect for it's even resolved to be honest with you. Hopefully by the end of the state will change the law, reflect what supposed be happening. I would hope it's more of one of those types of things where we say, well, it's not the county's fault. We're following with the law. Said we need to talk to the state as far as our handling. And then maybe the state has some type of settlement saying, hey, okay, we'll fix things if you'll do this. I don't know. I'm not an attorney and don't tend to be the one, but it probably will take while and there's all these kinds involved. So hopefully maybe they'll be where different kinds can get involved based on their population or their different things. So, we won't have to pay a whole bunch per county. Maybe they can get together and choose one particular law firm to work on. But in a nutshell, that's kind of what's going on. Nothing that we have personally done wrong. We follow the state law.

**HIRE COUNTY ASSESSOR  
- APPROVAL**

Vice-Chairman Kevin D. Weston stated that the next item on the agenda is the approval to hire a County Tax Assessor.

Ray Minor made a motion to approve the hiring of a County Tax Assessor. John Gossett second the motion but I have a question: Is it same terms and length as we had last year?

J. Larry Miller: How Long? Three months?

Cindy Miklos, Supervisor of Assessments: \$20,000. Three months.

Brad Wilson: Thank you.

Vice-Chairman Kevin D. Weston: Any other questions?

Brad Wilson: And we are going to charge townships, correct? We don't need to put that in our motion.

Cindy Miklos, Supervisor of Assessments: But John had asked me in between meetings to come up with a price and I can let you guys know. That's what I was just trying to work on now. But if you guys want me to, and we can vote on that the next time if you guys want to say higher and then we can put that in the next meeting. I can go ahead and let him know. The assessor said he was interested, but he would like to start sooner because I don't think we've done this until later last year. But put it on the agenda next time to approve the amount. We're going to charge the townships if you want me to. I don't know that it's necessary, but we can.

J. Larry Miller: Well, it's not, I mean you have the authority to do it, don't you?

Cindy Miklos, Supervisor of Assessments: I do. Yeah.

Brad Wilson: I would still, I am for approving this tonight, but I would still like to have it voted on, on record of what we're going to charge. I would like to vote on that next time, that fee.

Cindy Miklos, Supervisor of Assessments: Okay, I'll get it to you and explain how I came up with the number that I came up with.

Brad Wilson: Just because I want it to be very public that we are charging for this.

Curtis Overton: And last year we got a return on our investment, didn't we? I mean we regain more than what we paid and lost taxes that were recovered.

Cindy Miklos, Supervisor of Assessments: Well, the county itself didn't because they get a percent or something. But over the years, yes, because he picked up, I think a million dollars' worth of stuff. So, I mean, yeah, it was well worth it. But the county actually didn't recover in one year.

Brad Wilson: And I also think us voting on it from here, Cindy takes that pressure off you. You're not the one coming up with this that the board voted on that date.

Vice-Chairman Kevin D. Weston: Any other questions? Okay take roll. On roll call vote, all voted yes.

**AIRBNB & VRBO BED
