- Beginning balance as of 06/16/2025 is \$6,984,858.00. Estimated ending of 06/30/2025 is \$6,417,862.

- We received the largest sales tax check to date this month in the amount of \$327,441.69
- Members of the board discussed length of time left on paying off the Courthouse, Treasurer Steve Vercellino said he would get exact numbers for them.
- Circuit Clerk Jim Muir came to speak about the financial burden that Safe-T Act has left on his office. The year prior to the Safe-T Act his office processed \$696,000 in bond money, the year after it was enforced his office processed an annual amount of \$2,300 in bond money.
