The meeting was called to order at 5:00 PM by Finance Chairman Brad Wilson. See above list of those attending, and also, those stating public comments and the topics of their comments.

County claims were then submitted and were approved and signed by all members present.

Franklin County Treasurer Steve Vercellino reported on the county finances...

- Beginning balance as of 9/15/2025 \$4,516,415. Estimated ending of 9/30/2025 is \$6,233,787.
- The full report can be viewed on www.franklincountyil.gov as 9/15/2025 Finance Meeting Attachment 1.
- The total for all districts with sales tax \$22,953,445
- 1st distribution payment is in the amount of \$1,073,751.
- Questions arose with the 1%...Treasurer thinks we could have the courthouse paid off in April at the earliest. Discussion followed...
- All board members received a copy of the Audit, we will have a discussion at the next meeting in October once everyone has gone through it.

Sheriff Bacon asked the board to consider approving them to get another K9 since they had one medically retired in January. The total \$14,388.00 and would be paid out of Opioid funds. A detailed estimate can be viewed at www.franklincountyil.gov as 9/15/2025 Finance Meeting Attachment 2.

Steve Vercellino Sr. came to speak on Tourism and some of things they are working on.

- They just got a 3-year contract signed for Youth Archery Tournament. This is a huge event and will bring a lot of revenue to Franklin County. They have competitors from 23 different states that come to this event.
- Tourism received 2 grants this year, one for \$36,312.39 and another for \$54,476.78
- They turned their checking account into an interest earning account recently.

Judge Giacone here to talk about Franklin County part-time Public Defenders.

- States Attorney and Public Defenders office are under resourced.
- Both of our part time public defenders have to run private practices in order to make ends meet. Both are wanting a new contract or they both will have to resign.
- Surrounding counties who see fewer criminal cases are not only getting paid more with benefits but also have more assistants overall.
