ANNUAL ABATEMENT ORDINANCE

ORDINANCE NO. 2025-06

ORDINANCE abating the tax hereto levied for the year 2025 to pay the principal of and interest on \$2,910,000 General Obligation Bonds (Alternate Revenue Source), Series 2012, of The County of Franklin, Illinois.

WHEREAS the County Board (the "*Board*") of The County of Franklin, Illinois (the "*County*"), by an ordinance adopted on the 2nd day of April, 2012 (the "*Ordinance*"), as supplemented by a Notification of Sale, dated April 4, 2012, did provide for the issue of \$2,910,000 General Obligation Bonds (Alternate Revenue Source), Series 2012 (the "*Bonds*"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS the Board has determined that funds are or will be available to pay all principal of and interest on the Bonds due on December 1, 2026, and June 1, 2027; and

WHEREAS it is necessary and in the best interests of the County that the tax heretofore levied for the year 2025 to pay such principal of and interest on the Bonds be abated;


NOW THEREFORE Be It Ordained by the County Board of The County of Franklin, Illinois, as follows:

*Section 1. Abatement of Tax.* The tax heretofore levied for the year 2025 in the Ordinance is hereby abated in its entirety. This abatement ordinance does not abate the 2025 bond and interest levy adopted by the county board in its annual levy ordinance scheduled for adoption on December 15th, 2025.

*Section 2. Filing of Ordinance.* Forthwith upon the adoption of this Ordinance, a certified copy hereof shall be filed with the County Clerk of the County, and it shall be the duty of said County Clerk to abate said tax levied for the year 2025 in accordance with the provisions hereof.

Section 3. *Effective Date.* This Ordinance shall be in full force and effect forthwith upon its passage by the Board.
