Thank you for your attention to this matter and for your continued support of the Board’s mission.



On August 12, 2025, Cheryl Herron submitted a formal letter of resignation from the Franklin County Community Mental Health Board. On August 14, Dee Harp also submitted her formal resignation from the Board. Both resignation letters are attached for your review.

During the October 14 board meeting, members of the Franklin County Community Mental Health Board discussed the resignations and considered potential candidates to recommend to the County Board for appointment.
